

- 5 Seventeen Lecturers i.e. three in Anatomy, one in Physiology, three in Pharmacology, two in General Pathology, one in Microbiology, three in General Medicine, three in General Surgery and one in Anesthesia are absent in medical faculty.
- 6 Number of patients are less to teach the B.D.S & M.D.S students as per DCI norms.
- 7 No qualified Dental Hygienist and Dental Technicians were present. As per norms 10 Dental Technicians and 5 Dental Hygienist are required.
