NOTICE

A new revised FAQ dated 9th April, 2018 has been uploaded on the website on the basis of new Notification of MCI dated 7th April, 2018. Candidates are advised to go through the FAQ's carefully before participating in Round II of Counseling starting from 11th April, 2018.

The Following are salient points of Revised FAQ's:-

- ➤ Candidates who had participated in Round I and were allotted a seat but did not report to the allotted institute can log in again in round II as per their earlier registered details.
- Round I candidates who reported but resigned from allotted college are eligible to participate in Round II counseling without any fresh Registration / Payment. They can directly **Log In** as per the earlier registration details.
- ➤ Round I candidates who joined Round I seat but could not be upgraded in Round II shall be allowed to resign from Round I seat within two days of Round II Result publication (i.e. by 16th April,2018 till 5.00 pm server time) with Forfeiture of Fees.
- ➤ Candidates who have joined Round II allotted seat (of AIQ/ Deemed/ Central Universities) will not be allowed to leave the allotted seat and also their names will be circulated to all concerned Counseling authorities, making them non eligible for further rounds of counseling.
- ➤ There will not be any upgradation from Round II of Deemed/ Central Universities into DGHS Mop Up Round.
- ➤ Candidates who have been allotted seats in Mop up Round and joined the Mop Up Round seat will not be allowed for upgradation to Stray Vacancy Round by Deemed / Central Universities and their names will be circulated to all concerned Counseling authorities, making them ineligible for further rounds of counseling.
- ➤ Candidates are advised to read all the eligibility conditions for Round II, Mop Up Round and Stray Vacancy Round in FAQ's before participating in Round II of Counseling.
