

### **Admission Notice PG Medical courses under NEET-PG-2019.**

The Govt. of India vide letter dated 8.5.19, slashed the cut off for NEET PG by 6 percentile in each category. Online registration/applications are invited from now eligible candidates as per revised cut off percentile for stray vacancy round of counselling alongwith requisite fee for admission to MD/MS/PG Diploma/PGDSM/six months training in Ultrasonography courses upto **15.05.19** through university website. The revised qualifying percentile is as under :

The candidates will deposit fee of Rs. 5000 (SC Rs. 2500) through Challan form generated after successful filling of online application in the OBC Branches upto **16.05.19**.

### **Stray Vacancy round of Counseling for PG Medical/Dental Courses, 2019.**

Stray vacancy round of counseling for PG Medical/Dental Courses under NEET PG-2019 will be held on **17.05.19** at **Senate Hall, Baba Farid University of Health Sciences, Faridkot at 10.00 AM.**

Candidates will bring hard copy of online application form alongwith self attested and original certificates /documents at the counseling venue.

1. 6 months fee from selected candidates will be collected at the venue of counselling in the shape of DD favouring Registrar, BFUHS payable at Faridkot. Neither Cash/cheque nor online payment & part payment will be accepted. Candidates not having requisite DD at the time/venue/turn in counselling shall not be considered.
2. Penalty regarding forfeiture of fee and seat blocking in common counseling for admission to PG courses shall be as per MCI New Delhi notification no. MCI-18(1)/2018-Med./100818 dated 05.04.18, already put up on university website.
3. Candidates who are holding a seat of Round 1, Round 2 and Mop Up round, are not eligible for stray vacancy round. Remaining candidates who have applied in any of above rounds but are not allotted a seat, are still eligible for stray vacancy round and they need not to apply afresh.
4. Process of counseling is as per FAQs of MCC & other notices posted on the website from time to time.
5. Tentative vacant seats is available on University website. Final list of vacant seats will be displayed on the spot at the counselling venue.
