

Procedure for seeking admission to MBBS/BDS under Foreign Indian Students (NRI) Quota affiliated to the BABA FARID UNIVERSITY OF HEALTH SCIENCES, FARIDKOT, PUNJAB(INDIA)

Session – 2016

The following procedure of admission is as per Punjab Government notification no.5/5/2016-5HB-3/2775 dated 10.06.2016. Relevant clauses of notification are as under:

Clause 2

*All admissions of Govt. Quota seats in Govt. and Private Institutions shall be based on merit of Punjab Medical Entrance Test-2016 (PMET-2016) and all admissions in Private/Minority Institutions in Management Quota Seats **including NRI and Minority Quota seats shall be based on merit of National Eligibility cum Entrance Test (NEET-2016) as per Ordinance dated 24.05.2016 issued by Government of India.***

Clause 4

Admission to NRI seats of Govt. Medical Colleges shall be based on merit of separate entrance test to be conducted by BFUHS Faridkot.

Introduction:

1. **For Government/ University Colleges** candidates must have qualified separate entrance test to be conducted by BFUHS, Faridkot for admission to MBBS/BDS courses under NRI quota.
2. **Separate Entrance Test will be conducted on 09.08.2016.**
3. After getting provisional Eligibility/Equivalency certificate, candidate have to apply on prescribed application from upto **05.08.2016** to the university for Separate Entrance Test/Counseling for admission to MBBS/BDS courses under NRI quota **in Government/ University Colleges only.**
4. **For Private Colleges** candidates must have qualified National Eligibility cum Entrance Test (NEET-2016) for admission to MBBS/BDS courses under NRI quota.
5. After qualifying National Eligibility cum Entrance Test (NEET-2016) and getting provisional Eligibility/Equivalency certificate, candidate has to apply on prescribed application form to the university for Counseling for admission to MBBS/BDS courses under NRI quota in Private Colleges.
6. Candidates must have cleared 10+2 school qualification with Physics, Chemistry, Biology/Bio Technology and English and must have obtained a minimum of 50% marks taken together in Physics, Chemistry and Biology/Biotechnology (PCB) in appropriate subjects from any of institution/ university/ board etc. recognized and approved by the Government/ University.
7. All applications for equation are required to be sent to the University at its official address Baba Farid University of Health Sciences, Sadiq Road, Faridkot 151203 (Pb.), INDIA on or before the expiry of the last date as may be prescribed.
8. Admission shall be strictly according to preference category wise merit as per the Punjab Govt. Notification and its amendments. After selection, the candidates will be required to deposit the prescribed fee as per instructions.
9. For specific last dates for submitting applications and date of counselling and other information please keep yourself updated by visiting our University website www.bfuhs.ac.in from time to time.

Procedure for getting Eligibility Certificate

Before applying for admission under Foreign Indian Student(NRI) quota a candidate needs to seek Equivalence/Eligibility certificate from BFUHS by applying on prescribed application performa available on University website www.bfuhs.ac.in and it may be sent to the University alongwith fee of **US\$ 1000** plus **Rs 1000/- or equivalent in US\$** being the cost of the application form in the shape of demand draft/cashier's cheque in favour of the Registrar, Baba Farid University of Health Sciences, Faridkot drawn on any bank payable in India. I

The applicant has to attach following documents along with the application:-

- (i) 10+1/ equivalent examination detailed marks certificate(s)
(The certificate(s) must show the marks of Physics, Chemistry, Biology & English)
- (ii) 10+2/ equivalent examination detailed marks certificate(s)
(The certificate(s) must show the marks of Physics, Chemistry, Biology & English)
- (iii) Explanation Sheet of grades.
- (iv) Pass Certificate/Diploma of 10+2 or equivalent examination.
- (v) Proof of Accreditation of School in case candidate pass his/her 10+2 or equivalent examination from institution situated in U.S.A
- (vi) Detail of Grades of Qualifying examination.
- (vii) Date of Birth Certificate/matriculation (10th) certificate.
- (viii) Character/Recommendation Certificate from the Head of the Institution last attended.
- (ix) Proof of NRI status of candidate/parents

Note:- These documents should be original along with photocopies duly attested by a competent authority.

After verification of the documents, the university will issue Eligibility/Equivalency Certificate to the Eligible candidates only, and all original documents will be returned in person at the time of issue of Eligibility/Equivalency certificate.

2. Procedure for admission to State/University/Private colleges

- * After getting the Eligibility Certificate from the University, the candidate has to apply for admission on the prescribed Admission Application form to the Registrar, Baba Farid University of Health Sciences, Faridkot.
- * The candidate can also down load Admission Application form from the website of the University www.bfuhs.ac.in . site, he will have to send a demand draft of US \$ 1000/- or its equivalent amount in India rupees plus a demand draft of **Rs.2000/- or equivalent in US \$** in favour of Registrar, Baba Farid University of Health Sciences, Faridkot drawn on any bank payable at Faridkot towards the cost of this form.

The candidate has to attach the photocopies of the following documents duly attested by the competent authority along with application form:-

- (i) 10+1/ equivalent examination detailed marks certificate(s)
(The certificate(s) must show the marks of Physics, Chemistry, Biology & English)
 - (ii) 10+2/ equivalent examination detailed marks certificate(s)
(The certificate(s) must show the marks of Physics, Chemistry, Biology & English)
 - (iii) Copy of certificate of qualifying examination (Certificate/Diploma)
 - (iv) Explanation Sheet of grades.
 - (v) Date of Birth Certificate.
 - (vi) Character/Recommendation Certificate from the Head of the Institution last attended.
 - (vii) Eligibility certificate issued by the Baba Farid University, Faridkot.
 - (viii) Three latest colour signed and attested photographs (Passport size).
 - (ix) The candidate applying under category (I) & (II) are required to submit
 - a. Photostat Copies of the passport of Father/Candidate.
 - b. Proof of having ancestral background of Punjab/Other State.
 - (x) Demand Draft/ Cashier's Cheque for US \$ 1000 or equivalent in Indian Rupee.
 - (xi) Provisional Student Visa, if required.

Eligibility criteria

- a) **For Government/ University Colleges** candidates must have qualified separate entrance test to be conducted by BFUHS, Faridkot for admission to MBBS/BDS courses under NRI quota.
- b) **For Private Colleges** candidates must have qualified National Eligibility cum Entrance Test (NEET-2016) for admission to MBBS/BDS courses under NRI quota.
- c) Candidate should have attained or will attain the age of 17 (seventeen) years as on 31st December 2016. Candidates born on or after 02.01.2000 are NOT ELIGIBLE to apply.
- d) They should have passed in such qualifying examination from a recognized institution in the subjects of Physics, Chemistry, Biology/Biotechnology and English separately and should have obtained at least **50% marks in Physics, Chemistry, Biology/Biotechnology (PCB) taken together**. Candidates seeking admission under Foreign Indian Student (NRI) quota are required to must appear for counseling before the Selection committee.

Preference- :

The criteria laid down for admission against seats reserved for NRI Candidates will be as under:-

Category I : NRIs who originally belonged to the State of Punjab.

Category II : NRIs who originally belonged to an Indian state other than Punjab.

- (a) The student will have to give a bank guarantee/surety bond for the residual fee, if he/she opts to pay the fee in installment as provided.
- (b) The candidate shall be eligible only if they deposit the fee in foreign currency from their own/Parents NRI account.

Note 3

1. All original documents are required to be submitted at the time of applying for EQUATION/ELIGIBILITY CERTIFICATE.
2. Statements of result issued by School/College and the un-authenticated Result Notification/ Result Slip etc. will not be accepted.
3. Candidates must have 'Provisional Student Visa' from the Indian Mission abroad before admission and once he/she gets the confirmed admission, 'Student Visa' can be obtained from FRO/FRRO, on their own.
4. Candidates shall also be required to obtain a Clearance Certificate from the Ministry of Health and Family Welfare, Nirman Bhawan, New Delhi in due course and submit it to the Principal of the college to which they are admitted.
