**2. ELIGIBILITY**

- i) The sole manufacturers of Cylinders/Medical /Gases or their authorized agents/distributors may quote their rates.
- ii) In case of Authorized Supplier/Agency/Distributor, the Authorization Certificate as per the Format given at Annexure-‘V’ should be attached.
- iii) The firm should have been in existence for at-least three years and it should have annual turnover of at least Rs.20,00,000/- (Rupees twenty lacs only).
- iv) The bidder should have past experience for supply and refilling of Medical Gases in Cylinders to Hospitals at least three or more reputed Hospitals. At least one Hospital should have the bed capacity of 300 Nos. of beds. Bidder profile with the complete detail must be filled in the format given at **Annexure- ‘A’** by the participating Tenderer for the purpose of Technical Evaluation of bid.

**3. CRITERIA OF EVALUATION OF PRICE BID**

- i) The Price Bids shall be evaluated on the basis of lowest bid criteria without compromising on the quality of material. Rates of all types of taxes as applicable during the contract period should be quoted clearly. No other document / paper shall be attached to the financial bid.

- ii) The Tenderer whose rate on overall basis for all kind of gases are found lowest shall be given preference over other Tenderers. If no Tenderer quotes rates for all kind of gases, then only each Gas wise L-1 shall be considered and multiple Annual Rate Contracts shall be determined.

**4. PERIOD OF CONTRACT:**

The Rate Contract will be signed initially for period of one year which can be extended extendable up to another one year subject to satisfactory performance of the firm and timely supply of the material, on the same terms and conditions.

**5. SECURITY DEPOSIT:**

The successful bidder shall be required deposit a security of an amount equal to 10% of the final bid in the shape of Demand Draft in favour of Principal, Guru Gobind Singh Medical College & Hospital, Faridkot drawn on any commercial/nationalized bank, payable at Faridkot, before signing of this agreement. The EMD will be refunded on receipt of Security Deposit.

6. The Earnest Money Deposit will be refunded to the unsuccessful bidders within three months of the date of award of Rate Contract.
7. Merely issuing of bid document shall not constitute that the bidders are automatically qualified.
8. Even after award of contract, if, information/facts submitted by the bidders are found misleading/incorrect/false etc. Principal GGSMCH, Faridkot, reserves the right to disapprove / terminate the contract without any notice.
9. The tenderer on whom Notification of Award is issued shall have to enter into Contract within 15 Days time from the Date of Notification of Award. The Contract shall be executed on Non-Judicial Stamp Paper worth of Rs. 100/-, cost of which shall be borne by the Tenderer.
10. The Bidder/Agency shall not engage any Sub Contractor or Transfer the Contract to any other person during the concurrency of this Annual Rate Contract.
11. In the event of any breach/violation or contravention of any terms and conditions contained therein by the Bidder/Contractor/Agency, the said Performance Security Deposit will be forfeited.
12. The bidder will provide the required number of Cylinders to GGSMCH Faridkot and will quote their rent in the Price Bid in the Specified Column and these Cylinders are required to be utilized for supply and refilling of Medical Gases during the concurrency of Annual Rate Contract Period on F.O.R. to GGSMCH Faridkot only and the Selected Agency shall not takeout these Empty Cylinders without prior intimation and approval of Competent Authority/Controlling Authority from GGSMCH Faridkot premises on each occasion for refilling.

13. The Medical Grade Oxygen, Nitrous Oxide in cylinders should conform to specification IP2010 (Indian Pharmacopoeia) standards.
14. The delivery of filled cylinders and collection of empty cylinders from GGSMCH Faridkot premises shall be the responsibility of the Tenderer.
15. The bidder should have suitable arrangements for emergency supplies and also round the clock service.
16. The supply will be based on rental type for Oxygen, (1.25 Cum) 'B' Type.
17. Proper steps should be taken from vendor side on cylinders safety, maintenance & arranging safety and operation training for manifold operator.
18. There should be proper color coding for oxygen, nitrous oxide and CO2 cylinders.
19. The cylinders from the bidder side should have PROPER VALVE GUARD with anti-tamper sealing.
20. The cylinders should be checked and tested as per the PESO (PETROLEUM AND SAFETY ORGANIZATION) rules and regulations every five years.
21. It is desirable that the firm should have WHO GMP/DGQA/ISI/BIS Registration certificates with the validity of drug license.
22. Manufacturers should have its own IP (Indian Pharmacopoeia) testing labs at their production facilities.
23. The bidders should check periodically for any microbiological contamination and would provide certificate of the same.
24. The vendor should totally avoid the use of fluorinated and halogenated polymers which have a potential risk of catching fire.
25. Dedicated gas cylinders should be used for medicinal gases. These cylinders are specially treated to fill medical grade gases
26. In case there is leakage of any cylinder due to any defect of cylinder, the supply will not be accepted.
27. The rates quoted should be justified as the lowest quoted for any Govt. or Pvt. Hospital in India. If the price of any item is reduced due to any reason during the currency of the Contract, the Supplier Agency/Contractor will intimate the reduced price immediately and will charge as per the reduced rates.
28. No hike in rates shall be allowed during the currency of the Contract under any circumstances.
29. To enable daily supply, it will be binding on the Supplier to maintain adequate stock of relevant Gas Cylinders as per the requirement of the Hospital failing which, a

penalty equivalent to minimum 1% subject to maximum 5% of the delayed supply on each occasion shall be imposed. If the supply is delayed continuously 3-4 times, the contract is liable for Termination by serving 1 Month Notice. Consequently the Performance Security Deposit shall be forfeited and the Agency/Contractor shall be blacklisted/Debarred.

30. Tenderer should indemnify GGSMCH Faridkot and give an undertaking stating that if the firm fails to maintain standard laid down for medical gases usage, transportation, refilling, handling and any mishap occurs during medical Gas Supply to GGSMCH Faridkot, the firm will be responsible as per existing laws to bear all the cost and compensate the victims (if any).
31. Rejected supply should be taken back and be replaced by the supplier within the specific period as instructed by the Controlling Department of GGSMCH Faridkot. In case of failure to do so, Principal, GGSMCH reserves the right to dispose off the rejected supply if not lifted from the Hospital Complex of GGSMCH, Faridkot by the Supplier Agency/Contractor within the stipulated period and against the same no payment shall be made to the Supplier Agency/Contractor.
32. The Principal, GGSMCH Faridkot reserves the right to cancel/reject full or any part of the tender without assigning any reason.
33. **ARBITRATION**
  - i) In the event of any dispute or differences arising between the parties with regard to the terms and conditions of the agreement/contract and/or with regard to the breach or interpretation thereof including all rights and liabilities there under on any matter whatsoever touching upon the terms and conditions of the agreement/contract whether in course or on after its termination the parties will settle the same at the first instance by mutual discussions/conciliation which would be conducted by the GGSMCH.
