8. CRITERIA FOR EVALUATION OF PRICE BID

The Price Bids of technically qualified bidders shall be evaluated on the basis of lowest bid criteria without compromising on the quality of material. Rates of all types of taxes as applicable during the contract period should be quoted clearly.

9. **SECURITY DEPOSIT:**

- i) The successful bidder shall be required to deposit a security of an amount equal to 10% of the final bid in the shape of Demand Draft in favour of Principal, Guru Gobind Singh Medical College & Hospital, Faridkot drawn on any commercial/nationalized bank, payable at Faridkot, before signing of this agreement.

10. PAYMENT TERMS

The remaining 20% payment will be released after 60 days of successfully running of the gas pipeline system and satisfactory performance. The material will be accepted only if it is found as per approved specifications.

11. PENALTY CLAUSE

If the supply is not made within the stipulated period then late delivery charges @2% will be imposed on the total amount of Supply Order up to delay of 30 days and thereafter @ 4% for another 30 days after which Supply Order/Rate Contract will be deemed cancelled & security/earnest money forfeited and company will be black-listed for future.

12. **ARBITRATION**

- i) In the event of any dispute or differences arising between the parties with regard to the terms and conditions of the agreement/contract and/or with regard to the breach or interpretation thereof including all rights and liabilities there under on any matter whatsoever touching upon the terms and conditions of the agreement/contract whether in course of or after its termination the parties will settle the same at the first instance by mutual discussions/conciliation which would be conducted by the Principal, GGSMCH, Faridkot.
- ii) In the event the said mutual discussions/conciliation fails, the aggrieved party shall initiate arbitration proceedings for resolution of differences/disputes etc., mentioned above by appointing a sole arbitrator, who shall be the Registrar, BFUHS, Faridkot in which event the said proceeding shall be conducted in accordance with the provisions of the arbitration and conciliation.
- iii) The venue of such arbitration proceeding shall be at Faridkot and the court in Faridkot alone will have jurisdiction in respect of all proceedings connected there with.

Technical requirements for rate contract for Medical Gas Pipeline System & Accessories

- 1. Supply and installation of medical gas pipeline system including copper pipe, valves, valve box, alarm system and gas outlet points.
 - a. Price should be inclusive of Installation, testing and maintenance charges for 5 years, warranty for 5 years and inclusive of installation and fixing of bed head panel procured by tenderer.
- 2. Supply of (Price should be inclusive of warranty, with maintenance at tenderer's site for 5 years):
 - a. ward vacuum units
 - b. flow meters units
 - c. bed head panels
- 3. Items at S.No 1, 2a, 2b, 2c shall be considered as separately items and separate rate contract shall be signed for them individually.
- 4. All prices quoted should be inclusive of service charges. VAT and service tax shall be additional as applicable (to be mentioned along with bid). Bidder should specify the material and service component for tax calculation
- 5. Price shall be applicable for modifications in existing system also

TECHNICAL SPECIFICATIONS OF MATERIALS TO BE SUPPLIED GAS PIPE LINE, FITTINGS, VALVES, VALVE BOXES - Specifications

Gas pipe line, fittings and valves: The piped distribution system shall use copper pipes manufactured from phosphorous de-oxidised non-arsenical copper, seamless, half hard, and tempered to comply with ASTM B819 or EN 13348:2001 standards. Pipes are to be degreased suitable for oxygen use. Each lot should have manufacturer's Test Certificate and preferably inspected by reputed third party inspection agency.

a) The pipe sizes to be used are from among as under:

- b) Rates to be quoted separately for each size of pipeline in meters and measurement on site shall be rounded off to the next centimeter after total measurements
- c) Fittings shall be end fed type, manufactured from the same grade of copper as the pipes and be in accordance with the requirements of BS EN 1254-1: 1998 Part 1. Fittings shall be degreased to be suitable for oxygen use and copper fittings shall be considered as a part of running length of pipe and will not be counted separately.

- d) Copper to copper joints shall be made on site using (5% silver) silver-copperphosphorous brazing alloy to BS 1845 using an oxygen free nitrogen inert gas shield and no flux.
- e) Copper to brass or gunmetal joints shall be made with 43% silver, silver-copperphosphorous brazing alloy
- f) Except for mechanical joints used for components, all metallic pipeline joints shall be brazed or welded. The method used for brazing or welding shall permit the joint to maintain their mechanical characteristics up to 6000C. Filler metal for brazing shall nominally cadmium free (less than 0.025% mass fraction).
- g) Pipelines should be supported at the intervals specified in HTM 2022/02-01 using a suitable medical grade material
- h) Specs for manual floor isolation valve should be brass body with PTFE Seat and SS ball. Each Medical gas line ball valve assembly shall terminate in copper stub pipes to enable brazing direct into the distribution system using the flux less brazing technique. Valve should have adaptor on either side with O rings/sealing gaskets (nylon/PTFE) used for sealing, PTFE tape or any other thread sealing media is not acceptable. These adaptors should then be attached to brass nipple with NUT of appropriates size side with O rings/sealing gaskets (nylon/PTFE) used for sealing, PTFE tape or any other thread sealing media is not acceptable. - i) **Test:** After erection, all the new pipes cleaned or purged with the help of dry nitrogen gas. And should be tested with dry nitrogen 1.5 times of working pressure for 24 hrs. System should be tested for integrity, leakage, obstruction flow, particulate contamination, pressure relief valve, and monitoring and alarm system.
- j) The pipes should be accompanied with manufacturer (OEM) test certificate for the physical properties & chemical composition.
- k) Pipeline laid should pass Lloyd certification testing for pipelines. Further tenderer may its own cost get the pipeline system so installed tested by a third party.
- Marking and color coding: Pipeline shall be marked with the name and/or symbol adjacent to shutoff valves, at the junctions and the changes of direction, before and after walls and partitions, etc. at the intervals of no more than 10 meter and adjacent to terminal units. Marking shall include arrows denoting direction of flow and letters used for marking not less than 6mm high. All the exposed pipes/should be painted with two coats of synthetic enamel paint & color codification to comply with ISO 5359. All concealed pipes to have gas identification bands/labels at appropriate distance. Similarly all pipes which need embedding in the wall will be tested/painted/labeled and properly insulated in accordance with ISO 5359.
- m) Valve boxes: Lockable non-interchangeable screw thread (NIST) fittings according to BS EN 15908 to be provided on one side of oxygen pipeline. Separate quote

(excluding cost of valve(s)) should be submitted for single, double, three and four service supply. Specifications of valves used in valve boxes shall be as defined elsewhere in this document.

MONITORING AND ALARM SYSTEM - Specifications

Area line pressure monitoring system

- 1) Separate quote should be given for one service, two services, three services and four service units.
- 2) All parameters should be displayed in digital form.
- 3) Signals should be auditory, visual and indicate color.
