### General Instruction and eligibility for grant of license for running canteen at SINPMS, Badal

#### **1. Qualification and Experience of Bidders:**

- a. The bidders should have experience of running of bakery shop or restaurant of fast food shops as an owner of the business for atleast 3 years
- b. Or should have been running canteen in an institution with more than 500 Student plus staff members for last 3 years consecutively (experience certificate in original issued by head of institution needs to be attached in original)

#### **2. Site visit:** The bidders may at their visit, survey and examine the site and its surrounding to obtain all the information regarding the canteen before bidding and entering into a contract on any of the working days between 9:00 am to 3:00 pm. The costs of visiting the site shall be at the bidders own expense.

#### **3. Clarification to bidding documents:** The prospective bidder requiring any clarification may contact the O/o Principal, SINPMS, Badal. The Principal, SINPMS, Badal will respond to any request for clarification which is sought earlier than seven days prior to the dead line for the submission of bids. However Principal, SINPMS, Badal will not be responsible for any delay on this account.

#### **4.** The bidders shall furnish and submit the bid earnest money Rs. 5,000/- by demand draft issued by a commercial bank in favour of The Principal, SINPMS, Badal along at least one hour before the auction time.

#### **5.** Bidder shall deposit non-refundable amount of ₹ 200/- as application fees in cash/DD at least one hour before the auction time

#### **6. Documents Comprising the Bids:**

The bidder shall submit following documents before at least one hour from auction.

- a. Signed copy of this notice and terms & conditions of this agreement.
- b. Refundable Demand draft for ₹ 5000/-
- c. Non refundable Application fees of ₹ 200/-
- d. One cancelled cheque of currently operation bank account as an identity proof.
- e. To verify experience of 3 years bidder must attached self attested copies of registration under Food, Safety and Standards Act, 2006 issued office of Civil Surgeon. (original of the same shall be verified for the highest bidder before award of licence)

#### **7. Bid Validity:** The bid shall remain valid for the period of not less than 90 days after the dead line date

#### **8. Bid Earnest Money:**

- A. The Earnest money of unsuccessful bidder will be returned after finalization of the Auction Procedures.
- B. The earnest money of the Successful bidders will be discharged after the bidder has signed the arrangement and furnished the required 'Security Deposit'. However the earnest money already furnished can be adjusted against the 'Security Deposit' as required.
- C. The bidder whose bid is acceptable will have to be deposit the Security @ 25% of the amount of annual contract price in the form of Bank Draft within 10 days of the receipt of letter of intent but before the start of the services.
- D. The bidder whose bid is acceptable will have to be deposit signed contract form on a non-judicial stamp paper and get agreement registered, within 21 days of the receipt of letter of intent but before the start of the services.
- E. The earnest money may be forfeited:
  - i. if the bidder withdraws the bid after Auction.
  - ii. In case of a successful bidder, if the bidder will fails within the specified time limit to sign the agreement and or Furnish the required 'Security Deposit'

#### **9.** Any effort by the bidder to influence any Official/Officers of the institute in the whole procedures may result in the rejection of the bidders bid.

#### **10. Award Criteria:** The Principal, SINPMS, Badal will award the contract to the bidder whose bid has been determined to be substantially responsive to the bidding documents and who has offered the highest bid price.

#### **11. Right to accept any bid, reject any or all bids:** The principal, SINPMS, Badal reserve the right to disqualify any bidder for auction & accept or reject any bid, and to cancel the bidding process and reject all bids, at any time prior to the award of contract without

thereby incurring any liability to the affected bidder or bidders or any obligation to inform the affected bidder or bidders of the grounds for Principal, SINPMS, Badal.

### Terms and Conditions for grant of license for running canteen at SINPMS, Badal

1. The bidders hereinafter referred to as 'Licencee' shall be covered by the provisions of the Public Premises (Eviction of Unauthorized Occupants) Act 1071, and Rules and Regulations framed there under, from time to time for the purpose of any action in case of default.
2. The LICENCEE shall pay to the Principal, SINPMS hereinafter called 'LICENSOR', monthly LICENSE FEE for the first month shall be paid within seven days from the issue of authorization letter for taking possession of LICENSED premises but before taking over of the actual possession. Failure to pay will lead to withdrawal of license beside recovery therefore along with 18% interest per annum on the delayed license fees.
3. The term 'LICENSED PREMISES' shall mean the existing canteen area in the commercial complex at SIMPMS, which shall include current cooking area and the service hall.
4. The intent of this LICENSE is to facilitate the student and staff of the SINPMS by provided them with quality and cost effective canteen services.
5. License fees for the subsequent months shall be payable by 7<sup>th</sup> of that month. License fee has to be paid by crossed cheque in favour of 'Principal, SINPMS, Badal' from the bank account of the licensee. Failure to pay by applicable date will lead to withdrawal of license beside recovery therefore along with 18% interest per annum on the delayed payable amount.
6. In addition to the license fee, the licensee shall pay electricity consumption according to the reading of electricity sub-meters (electricity meter approved by PSEB to be installed by licensee at his own cost) and arrear, if any will be recoverable from the security. Such payment shall have to be made by the licensee by 7<sup>th</sup> day of next month. Failure to pay by applicable date will lead to withdrawal of license beside recovery therefore along with 18% interest per annum on the delayed payable amount.
7. In addition to the license fee, the licensee shall also pay for water consumption at flat rate of ₹ 200/- per month. Such payment shall have to be made by the licensee by 7<sup>th</sup> day of next month. Failure to pay by applicable date will lead to withdrawal of license beside recovery therefore along with 18% interest per annum on the delayed payable amount. Either party may request for installation of water sub-meters (approved by PWD, to be installed at the cost to be borne by licensee cost) and arrear, if any will be recoverable from the security.
8. Charges for electricity consumption and water consumption shall be payable 7<sup>th</sup> of next month.
9. The license shall be initially for a period of one year but renewable on yearly basis commencing from the date from which the possession of the permission is taken or from the eight day of the issue of authorized letter for taking possession of the premises, whichever is earlier? The license is extendable on yearly basis subject to the satisfactory service of the licensee and solely at the discretion of LICENSOR up to maximum of two more terms of one year each with 10% increase in yearly license fee for each term and for the period deemed fit by LICENSOR. The licensee shall not be eligible for such extension as a matter of right and the decision of the Licensor, shall be final and binding. In case of default the provisions of PP act, 1971 shall be invoked. On the expiry of the terms of the license period, the licensee shall handover vacant possession of premises in good condition.
10. Notwithstanding anything contained in this license contract, the licensor in the interest of the institution and its students shall be at liberty to terminate this license by giving 30 days clear notice. Similarly licensee may request for termination of license giving 30 days clear notice.

11. The 'Security Deposited' or remainder therefore, if not forfeited shall be refunded to the licensee after the expiry of the license and after the handing over of the vacant premises by the licensee after adjusting dues if any.
12. The licensee shall use the premises solely for the sale of items as per Annexure-I & 2 only and for no other purpose, no other items and at prices not exceeding as specified in annexure-1&2 and shall not part with the premises/Sub-let the premises to any one directly or indirectly. 10% yearly increase (if extension is granted) shall be allowed on the sale of items/services where rate are fixed in the annexure I
13. Neither this license nor any of the right conferred by it shall be transferred or assigned to any other person, nor shall the premises or any part thereof be sublet directly or indirectly.
14. The licensee shall not make any addition or alternation in the premises or take any other encroachment thereon without the prior written permission of the licensor.
15. Licensee may request for inclusion of additional items/brands relevant to the business of canteen service and the Licensor shall be at the sole discretion to allow for the same with price fixed accordingly.
16. The licensee will display the rate of goods to be sold at premises as per the approved charges and agree to ensure that the rate list is displayed clearly at all times.
17. Licensor by issuing the license provides no exclusivity for the service offered in the license. Licensor shall be free to enter into any type agreement/contract with another agency at deemed appropriate by the licensor and such another agreement/contract shall be at the discretion of the licensor.
18. The licensee shall comply with the directions of Licensor in the matter and manner of utilization of the licensed premises and to keep the premises in a clean, sanitary and tenable conditions and shall pay for the cost of making good any damage thereto or to adjacent premises, caused by negligence or misuse of premises by the licensee and shall indemnify the licensor against any loss or damage to the premises caused by fire.
19. The licensee will comply with requirement of Food Adulteration Act, Industrial laws labour act and other applicable laws/Acts, as applicable from time to time and will be liable himself for any contravention thereof. Licensee, by bidding for the license agrees to keep the Licensors indemnified for violation of laws (if any) by the licensee and to make up for losses incurred by the licensor due the violation by the licensee
20. The licensee shall ensure promptness of service at the counter or the premises and cleanliness of the premises and shall appoint necessary staff for the purpose and shall also ensure that there is no misbehaviour or mis-management on his part or his servants.
21. Licensee needs to understand that majority of the students at SIMPMS are female students and the licensee and its employees need to maintain distance from student. Licensee by bidding for the canteen service agrees that majority of the employees of the licensee shall be female employee and any/all of the male employees shall be above 40 years. Licensee shall submit details of all the person proposed to work under this license and such person shall be put on job only after the consent of the licensor who shall check the compliance to above age and gender requirements. Licensee agrees to remove his employee(s) from the licensed premises found creating nuisance or indulging in unacceptable conduct, on a simple request of the licensor with immediate effect.
22. The licensee will submit list along with photographs of the workers with addresses. And ensure that female attendant will attend to students at counter.
23. In case of breach of any of the terms and conditions of this contract the licensor may revoke the contract and forfeit the 'security deposited' and the licensee shall there up to forfeit, the right here under and shall remains liable for any sum the due from him and also for any damage or loss which may be caused, the licensor by reason of such default or for making any alternative arrangement for running the said premises.
24. The licensee shall deliver the vacant possession of the premises in good condition free of all damage to building & supply lines etc. to the licensor after the expiry or revocation of the contract/license.
25. At the expiry of the License period, should there be any delay by the Licensee in vacating and handing over the vacant premises to the Licensor, the LICENSED PREMISES, then this shall attract compensation at ₹ 5000/- per day payable to the licensor by the

licensee . This will be without prejudice to the rights of the Licensor to have the LEASED PREMISES vacated through the process of law by arbitration and the license shall be governed by the PP ACT 1971.

26. All dispute and differences arising out in any way touching this contract what so ever, shall be referred to decision to the sole arbitrator, who shall be the Registrar, Baba Farid University of Health Sciences, Faridkot. The licensee shall have no objection to the arbitration by the Registrar, Baba Farid University of Health Sciences, Faridkot on the ground that he had to deal with the matter relating to this contract or that he has had to deal with the matter relating to this contract or that he has expressed his view of matter in disputes in the discharge of his duties as an officer of the Corporation. The award of the arbitrator shall be final and binding of his duties as of the Corporation. The award of the arbitrator shall be final and binding on the parties of this contract. The arbitrator clause shall not be applicable after the expiry of term of the license or its revocation. This license will be governed by the PP Act 1971.
27. The licensee shall take all reasonable precaution to prevent any immoral or unlawful acts or disorderly conduct of his employees so deployed for rage protection of peace and protection of person and property of the Institute.
28. The contractor will provide service and material as per the menu and rates as at annexure I and 2

### **Notification of award and signing of agreement**

29. The bidder whose bid has been accepted (being the highest) will be notified by the Principal, SINPMS, Badal prior to expiration of bid validity period.
30. The notification of the award will constitute the information of contract, subject to the furnishing of a "Security Deposit" in accordance with the provisions
31. The agreement will incorporate all terms & condition of the contract and this document shall be treated as a part of the license agreement.
32. The successful bidder will sign the agreement in the prescribed form with the Principal, SINPMS, Badal & deliver it to the licensor along with requisite amount of security within 21 days of the receipt of " letter of Acceptance". The licensee shall execute necessary contract (license deed) in the Non-judicial Stamp papers at his own cost within fifteen days of issue 'Letter of Acceptance' and get the same registered with the office of the registrar, the original which shall be kept with the licensor. All the expenses incurred on the registration of license agreement shall be borne by the licensee.
