## Note-1:

The candidates who have applied under Sports category will have to submit printed / hard copy of online submitted application form personally (by hand) in the University upto stipulated period alongwith self-attested photocopies 10+1 & 10+2 DMC's, Sports Gradation Certificate issued by the Director, Sports, Punjab and other supporting certificates/documents.

Credit shall be given only for the sports achievements made during class XI and XII. The admission shall be made on the basis of inter-se merit of the candidates determined on the basis of gradation (Category A/B/C) issued by the Director of Sports, Punjab. However, for exempted categories under para 12 of this notification, the competent authority will be Director, Sports of that State of U.T. from where the candidate has passed the class XI and XII examinations.

**Note-2:** It is mandatory to upload the Detailed Marks Card (DMC) of 10+2 examination at the time of submitting online application form.

Note-2: Provisional Merit will be displayed on 02.08.2024. If any candidate found any discrepancy (except category once claimed) in his/her merit he/she shall submit objection with relevant documents through email id i.e <a href="mailto:ug2021bfuhs@gmail.com">ug2021bfuhs@gmail.com</a> for rectification till 03.08.2024(upto 02:00 pm), failing which he/she is not liable to claim his/her right to earlier seat, if cancelled due to discrepancy found at the time of checking eligibility/document verification by the Principal of allotted college. Thereafter, his/her candidature will be considered in 2nd round of counseling as per correction in merit.

Note-3: The allotment in the counseling will be provisional and subject to verification of original documents/checking of eligibility by the Principal of concerned College at the time of joining/reporting. It is sole responsibility of the Principal to authenticate the eligibility of the allocated candidate as per Punjab Government notification/prospectus before joining/admission.

**Note-4:** Other State candidates not considered under exemption clause will be considered in 2<sup>nd</sup>/subsequent counseling after exhausting Punjab State Candidates.

**Note-5:** He/she has completed age of 17 years at the time of admission or will complete that age on or before 31 December of the year of his/her admission. The candidates must have born on or before 31.12.2007 to the first year of admission in the undergraduate course.
