Subject:- Regarding Payment of TA/DA to Inspectors during Inspection of Colleges.

Dear Sir,

I am directed to invite your attention upon the subject cited above, vide which the Competent Authority has revised the rates for payment of TA/DA to inspectors during their inspections of various colleges, as detailed below:-

Details	Old Rates	New Approved Rates
Per KM Rate of Journey by <b>OWN CAR</b>	Rs. 10/- per KM Night Halt Charges @ Rs. 200/- per Night (if applicable )	Rs. 10/- per KM Night Halt Charges @ Rs. 200/- per Night (if applicable)
Per KM rate of Journey <b>BY TAXI</b> (against Taxi Receipt/ Bill)	Rs. 1100/- fixed upto 80 KMs	Rs. 1100/- fixed upto 80 Kms Or Actual Bill / Receipt of Taxi Usage (Whichever is less) And For each KM beyond 80 KMs of Journey there will be payment of Rs. 10/- per KM i.e. Rs. 1100 Fixed + Rs. 10/- per KM from 81 <sup>st</sup> KM onwards. And Rates for extra hours beyond 8 hours of journey @ Rs. 60/- per hour.  <b>Example:-</b> <i>If an inspector travels 100 KMs of journey through Taxi then he/she will be entitled to get Rs. 1100/- for 80 Kms And Rs. 200/- for remaining 20 kms (20 kms @ Rs. 10/- per Km) If the same inspector will spend 10 hours during journey then he will get Rs. 120/- extra (2 hours after 8 hours @ Rs. 60/- per hour = 120/- only).</i>

Important Note:-


- A) If an inspector is unable to produce Taxi Bill/ Receipt then he/ she will be paid TA equal to the TA rates fixed for usage of OWN Car rates i.e. @ Rs. 10/- per KM of journey performed.
- B) That as per previous practice, NO Honorarium will be paid to inspector concerned.
- C) That the College Branch may apply the said new rates upon the bills lying with it and the same rates will also be made applicable for the future TA/DA Bills of inspectors.


