Frequently Asked Questions (FAQs) for 1st Round of State Counseling for admission under NEET UG-2023

- 1 Ques: What is the last date of reporting the college provisionally allotted during Round-I State Counseling?
- **1 Ans:** The candidate who has been allotted seat on 05.08.2023 i.e during Round-I State Counseling shall report to their provisionally allotted college upto 08.08.2023(last date of joining).

2 Ques: What is the mode of payment of tuition fee?

2 Ans: The candidate can pay his/her six months tuition fee through online payment gateway only. The icon "Pay fee" is available besides the icon "Allotment Letter".

3 Ques: Whether tuition fee can be paid through Demand Draft or Cheque?

- **3 Ans:** Demand Draft or Cheque is not accepted.
- 4 Ques: Whether it is mandatory for the candidate to report to the provisionally allotted college?
- **4 Ans:** Mere paying the requisite amount of fee does not confer his/her right to the provisional allotment. Thus, it is mandatory to report to the concerned college. Therefore, the candidate who is interested to join the college shall only pay the tuition fee and report to the concerned provisionally allocated college.
- 5 Ques:Whether the candidate can claim his/her right to the concerned allotted seat if he/she does not join or surrenders the concerned allotted seat withing stipulated date and time of reporting/joining?
- **5 Ans:** The candidate who will not report/join the provisionally allotted college within stipulated date and time, he/she cannot claim his/her right for the particular allotted seat and resultantly the vacant seat will be added in the vacancy position for next Round.
- 6 Ques: Can the candidate surrender his/her allotted seat after joining the allotted college of Round-I and get the refund of tuition fee?
- **6 Ans:**The candidate can surrender the allotted seat in 1st Round before the stipulated date as per schedule to be published by this University after completion of 1st Round of online counseling only. The interested candidate who wants to surrender the joined seat of Round-I has to report to the Principal of concerned college and submit the application for surrendering the joined seat of Round-I so that your particular seat shall be surrendered on the online portal, otherwise the candidate will be considered as joined.
- 7 Ques:Whether the candidate who has joined the allotted college of Round-I can upgrade his/her seat during Round-II?
- **7 Ans:** The candidate who is interested to participate/upgrade his/her seat during Round-II has to submit willingness for Govt. Colleges only / Govt. &

Private Colleges(both) or Private Colleges only alongwith the security fee equivalent to the penalty amount as mentioned in the Notification MCI-34(41)/2018-Med./109835 dated 18.05.2018 issued by the Medical Council Committee available in the NEET UG-2023 prospectus:

- **Note**: The candidate has to submit the fresh choices/preference of Course/College/Quota/Category during 2nd Round of online counseling.
- 8 Ques:Whether the tuition fee paid at the time of joining in the provisionally allotted college during 1st Round of counseling will be adjusted against the willingness fee for participating in Round-II?
- 8 Ans: The candidates who have already deposited fee during Round-I equivalent to the security amount, need not to deposit the requisite fee otherwise remaining (proportionate) amount is required (as applicable).
- 9 Ques:Whether the tuition fee can be adjusted if the seat is upgraded in the Round-II Counseling?
- 9 Ans: Yes, the tuition fee will be adjusted and the candidate has to pay the remaining partial amount of tuition fee if required or the excess amount of fee paid will be refunded within a month after the completion of process of admission under NEET UG-2023 as per clause no. 14 "Fee" Note (ii) of Notification No. 5/5/2021-5HB-III/446 dated 10.03.2023.
- 10 Ques:Whether the candidate who is holding the seat of Round-I but will not submit joining in the new college on the upgraded seat allotted during Round-II can claim his/her right on the previous seat allotted during Round-I?
- 10 Ans:Once, the seat gets upgraded in Round-II, the seat of Round-I gets vacated automatically and offered to the candidate as per merit in the same round. Thus, no claim can be made on the previous allotment of Round
- 11 Ques:Whether the candidate has to register again for Round-II State Counselling?
- **11 Ans:**The candidate who has already been registered and paid the registration fee

need not to register again for Round-II Counseling.

12 Ques:Who is eligible for Round-II State Counseling?

- **12 Ans:**Candidates eligible for seat allotment in 2nd Round would be from one of the following groups:
 - **Group-I:** Registered candidates who did not get any seat allotment in the 1st Round.
 - **Group-II:** Registered candidates who have secured seat & whose 1st round of allotted seat got cancelled during the document verification on reporting for admission will be considered for allotment of seat in the next round of seat allotment with changed category, subject to availability of seat in respective category.
 - **Group-III:** Candidates who have reported at allotted institute during 1st round of allotment and submitted willingness for second round up-gradation as Yes.
 - **Group-IV:** Candidates who have been allotted a seat but Not Joined.
 - **Group-V:** Candidates who have resigned/surrendered during the time frame from the allotted seat of first round at college.

13 Ques: Who is not eligible for Round-II State Counseling?

- **13 Ans:** a) The candidate who has become non-eligible due to having inadequate documents as per Eligibility Criteria.
 - b) Who have not registered in Round 1 or Round 2.

14 Ques: What is the date of starting the process of Round II Counseling?

14 Ans:The schedule followed by the instructions regarding the process of Round-II will be uploaded on the University website i.e <u>www.bfuhs.ac.in</u> For updates kindly visit University website regularly.
