The candidate who have already registered during Round 1 & II (as per applicable rules) need not apply again. Date for fresh online registration/application and deposition of application and security deposit for fresh applicants alongwith fee of Rs. 5000+18%GST(Rs. 5900/-) and Rs. 2500+18%GST(Rs. 2950/- for SC candidates) through university payment portal. (Fresh registered candidates will have to submit willingness alongwith security deposit for 3 rd online counseling. Failing which their candidature will not be considered. Note: The candidate who has not joined/resigned the allotted seat of Round 2, will have to register afresh for 3rd round and will also deposit security amount again	08.10.2024 to 10.10.2024 (upto 02:00 PM)
3.	The last date for submitting willingness alongwith security deposit for 3rd round of counselling by all the candidates (already registered candidates and fresh applicants). The amount of security to be deposited for submitting willingness will be as under: For Government colleges - Rs. 10000/- (half for SC/BC) For both Govt. & Private Colleges – Rs. 2,00,000/- For Private Colleges – Rs. 2,00,000/-	08.10.2024 to 10.10.2024 (upto 5:00 PM)
4.	Last date for submitting admission application form for NRI quota (Application form for getting Eligibility certificate and admission application form for NRI candidates is separately available on University website)	08.10.2024 to 10.10.2024 (upto 03:00 PM)
5.	The candidates who will apply under Sikh Minority/Christian Minority Quota will report to the respective minority institution (SGRD Institute of Medical Sciences, Amritsar / Christian Minority College, Ludhiana) for verification of minority status. The candidates who have already got verified their minority status at the time of 1 st & 2 nd counseling, need not report to the respective institute for verify again. The candidates who have already registered under Minority Quota during 1 st & 2 nd counseling and did not get their minority status verified, can report to the respective institute for verification of their minority status for 3 rd round of counseling.	10.10.2024

10.	The last date/time of submission of objections to provisional allotment (if any) by the NEET UG aspirants Note: Objections can be submitted only by personal appearance/visit alongwith relevant documents/record in Admission Branch, BFUHS, Faridkot.	upto 20.10.2024 (03:00 PM)
11.	Display of revised provisional allotment / result after any change in provisional allotment due to objections (if any). Note: As per schedule of MCC 3rd round counseling, they will show the joined candidates data on 20.10.2024. Hence, the final allotment will be declared on 21.10.2024 after debarring the joined candidates (if any) from the provisional allotment of 3rd Round of Punjab State.	21.10.2024
12.	The provisionally selected candidates will pay the balance amount of fee (Six month fee after deducting amount of security deposit) through university payment gateway available on university website and will report to the respective college for joining in the respective allotted college.	21.10.2024 to 23.10.2024

Eligibility for 3rd Round of Counseling

- **The candidates who can apply afresh for 3rd Round of counseling (These candidates have to pay registration fee and security amount at the time of submission of willingness as per rules)**
 - The candidates who will register/apply for the first time.
 - The candidates who have not joined the allotted seat (fresh/upgraded) of Round-II counseling can apply afresh for 3rd Round and they will have to deposit security amount again for submitting willingness and choices/preferences of Course/College/Quota as per schedule.
- **The candidates who need not to apply afresh for 3rd Round of counseling**

- The candidates who are already registered but have not been allotted any seat in Round I and II need not to register/apply again.
- The candidates who have resigned/surrendered the allotted seat of 1stonline Counseling with free exit upto 06.10.2024(till 04:00 PM) and do not hold any seat of Round-I. However, they will have to submit Willingness alongwith requisite amount of security (equivalent to penalty) and will submit Choices/preferences of Course/College/Quota as per schedule.
- **The candidates who are eligible for 3rd Round of counseling**
 - **Candidates eligible for seat allotment in 3rd Round would be from one of the following groups:**
 - Group-I: Registered candidates who did not get any seat allotment in the Round 1 or Round 2.
 - Group-II: Registered candidates who have secured seat & whose 2nd round allotted seat got cancelled during the document verification on reporting for admission will be considered for allotment of seat in the next round of seat allotment, with changed Category, subject to availability of seat in respective category.
 - Group-III: Candidates who have reported at allotted institute during 2nd round of allotment and submitted willingness for third round for up-gradation
 - Group- IV: Candidates who have been allotted a seat in Round 2 but did not join or resign and exited after forfeiture of fees.
- **The candidates who are not eligible for 3rd Round of allotment**
 - Candidate who has become non-eligible due to having inadequate documents as per Eligibility Criteria.
 - Candidate who has not registered in Round 1 or Round 2 or Round 3.
- **Fee to be deposited by the candidates applying afresh for 3rd Round:**
 - For registration the candidate has to apply online application form and needs to deposit fee @Rs. 5000+18%GST (Rs. 5900/-) and Rs. 2500+18%GST (Rs. 2950/- for SC category candidates) through online payment gateway of University only.
 - For willingness, the following security amount is to be deposited through online payment gateway of University:

Amount to be deposited	Submission of Willingness for
Rs. 10000/-	For Govt. Colleges only
Rs. 200000/-	For Govt. & Private Colleges
Rs. 200000/-	For Private Colleges only

- **If any candidate wants to change his/her willingness from Govt. Colleges only to Private & Govt. Colleges/Private Colleges only:**
 - The candidate has to deposit the remaining security amount i.e. Rs 190000/- through online payment gateway of University.

Note: Already registered candidates who have deposited security amount in 2nd round counselling and to whom no seat is allotted in 2nd Round, need not to deposit security amount again. However, they will have to submit willingness to participate in 3rd Round, through online payment gateway of University.
