# **INTRODUCTION**

## **BRIEF HISTORY:**

The University was established at Faridkot under an Act of Punjab State Legislature (Punjab Act No. 18 of 1998) in the name of great Sufi Saint Sheikh Farid Ganj-E-Shakar, (1173-1265 A.D.) in 1998 for purposes of affiliating, teaching and ensuring proper and systematic instruction, training and research in Modern Systems of Medicine and Indian Systems of Medicine. It is not only affiliating and examining body but also a teaching and research centre in health sciences. It is expected to play a vital role in improving the standards of medical and health education in the state and in conducting relevant research in all aspects of health sciences, basic as well as applied, which ultimately will ameliorate the health standards of the people of Punjab. It is believed that the university will be a trend setter in developing appropriate modes and models of health care to ensure quality health care to the people.

The University has been recognized by MCI vide letter no. V/11015/3/2000-ME (UG) dated 9th June, 2000. The UGC has also included the University in the list of recognized universities maintained by the University Grants Commission, under section 2(1) of the UGC Act. 1956 vide letter no. F.9-3/97 (CPP-I) dated 4 July. 2002. The Regional Director. World Health Organization, Regional Office for South-East Asia, World Health House, New Delhi has also forwarded the name of the University for inclusion in the World Directory of Medical Schools vide letter No. M12/6212 dated 6 May 2002. The University is also included in the list of Commonwealth Universities and their yearbook 2001 at page No. 692 (Vol. I).

Established with a mission to create an intellectual, academic and physical environment conducive to free flow of ideas and exchange of information between various faculties of The University, between this University and other Universities of Health Sciences in the country and abroad, thereby opening a window to the world for the health professionals, health planners, health managers, biomedical and social scientists and educationalists in health sciences of the country. Efforts are on to establish contact with various institutions towards achieving this goal.

## **UNIVERSITY'S PRESENT STATUS:**

All the new buildings of the University and its constituent college, GGS Medical College & Hospital were completed in the year 2011. The University was shifted to its new building situated at Sadiq Road, Faridkot in July 2011. Hon'ble Chief Minister, Punjab inaugurated two new University buildings (Senate Block and Academic Block) on 22-09-2011. Hon'ble Deputy Chief Minister inaugurated the Radiotherapy Unit, and other buildings of GGS Medical College & Hospital, on 23-09-2011. The GGS Medical College & Hospital, a constituent college of the University is also shifted to its new building.

The University Campus comprises of GGS Medical College along with Auditorium of 800 capacity, Senate Block, Academic Block, University College of Physiotherapy, University College of Nursing, Drug De-addiction Centre, Telemedicine, Edusat and a well equipped state-of-the-art 500 bedded hospital. Coveted projects to set up Trauma Centre, Regional Cancer Centre all in process. The University has added to its academic convoy University Library & Informatics Division, Department of Health Sciences Library & Information System, University Centre of Excellence in Research, Rose Garden and Herbal Garden.

## **UNIVERSITY'S NEW PROJECTS:**

University has already established:-

- 1) Super Specialty Block in GGS Medical Hospital, Faridkot
- 2) Mother & Child Block in GGS Medical College, Faridkot
- 3) University Institute of Paramedical Sciences, Faridkot
- 4) Advanced Cancer Diagnostic, Treatment & Research Centre at Bathinda.
- 5) University Regional Centre for Public Health & Paramedical Sciences at Goindwal Sahib. University has acquired 20 Acres of land for its Regional Center at Goindwal Sahib. The University has planned to run a number of employment-oriented diploma courses and certificate programmes in Health Sciences.

## **UNIVERSITY'S CONSTITUENT COLLEGES:**

Guru Gobind Singh Medical College & more than 1000 bedded Hospital, Faridkot vide notification no. 8/02/2005-1HB-111/6308 dated 31.10.2006 and State Institute of Nursing & Paramedical Sciences, Badal vide notification no. 1/46/07-1HBIV/1163 dated 28.11.2007. In addition to above, there is physiotherapy college in the University campus. University has also established its own Institute of Pharmacy.

### **COLLEGES AFFILIATED WITH UNIVERSITY:**

At present the University is having 164 affiliated colleges( 09 Medical,14 Dental, 124 Nursing, 08 Physiotherapy, 1 Pharmacy, 1 Sports Medicine and 7 para medical) comprising 153 affiliated and 11 constituent Colleges.

University will soon endeavor to achieve excellence in health care delivery and Medical Education and Research in the State. Admissions to various undergraduate and post graduate courses in the affiliated institutions of this University in the State of Punjab are made on merit basis through the conduct of Entrance Tests.

The University is now primarily focusing on strengthening postgraduate medical education and research and evolving as a centre of excellence in a rural backdrop.

### **University Examination System:**

The University had introduced Onscreen Marking Solution w.e.f. session 2016 and e-transfer system of question papers of various courses to the examination centers to maintain the sanctity of examinations. ## **PART-A**

### **GENERAL INSTRUCTIONS (PLEASE READ IN DETAIL)**

1. This prospectus is divided into 3 parts:
  - Part-A Pertains to the general procedure for applying to admission, submission of admission application/counselling form, deposition of fee, important instructions, joining, etc.
  - Part-B Pertains to Intake/Eligibility criteria fixed for admission to Post Graduate Degree/Diploma Courses of Allied Healthcare Sciences.
  - Part-C Annexure/specimens of various categories, self-declarations.
2. The Prospectus comprising Admission Application Form will be available on the University website i.e <https://bfuhs.ggsmch.org/>
3. Candidates must strictly follow the instructions laid out in the Prospectus and University website. Candidates not complying with the instructions shall be disqualified.
4. This prospectus is subject to alteration(s) / modification(s) at any time without notice. Please visit University website from time to time. Admissions including Eligibility to allied healthcare science Courses (PG Degree/Diploma) shall be governed and regulated as per the rules and regulations etc, as per BFUHS norms.
5. Instructions in this prospectus are liable to change based on decision(s) taken by the Board of Management of this University from time to time. There is no equity or any rights that are/or deemed to be arising in favour of candidate.
6. The candidate should read the eligibility condition carefully. Mere submission of application for admission/counseling does not entitle him/her for admission. Eligibility conditions for admissions are specified clearly. The eligibility shall be determined by the Selection Committee/Principal of concerned college at the time of counseling/admission. Those who are not eligible as per eligibility criteria mentioned in the Prospectus will not be considered for admission. Eligibility is also subject to medical fitness.
7. Candidate's eligibility is purely provisional & subject to the fulfillment of eligibility criteria as per norms incorporated in this prospectus.
8. Applications of candidates producing false or fabricated information shall not be considered and candidates shall be further debarred from participating in any future counseling to be conducted by BFUHS, Faridkot.
9. Any attempt by a candidate to influence directly or indirectly any person concerned with the admission process will lead to disqualification of the candidate.
10. Seat matrix process shall be available on the university website at the time of counseling.
11. Allocation of seat is provisional subject to verification of original documents/checking of eligibility by the Principal of concerned Colleges. It is sole responsibility of the Principal to authenticate the eligibility of the provisionally allocated candidates before their joining/admission.
12. The fee structure of concerned college will be as notified in the Prospectus. If there would be any subsequent amendment for change in fee structure, the same will be applicable in letter and spirit.
13. In case of any discrepancy or contradiction in academic matters the University shall be the final Authority.
14. Deposition of fee does not confirm the admission of the candidate, if it is challenged in the Hon'ble

Court.

15. Changes, if any, in the Schedule / Counseling etc. shall be notified only through website of the University i.e. <https://bfuhs.ggsmch.org/>
16. The allotment of College to the applicants for admission shall be made as per merit determined on the basis of inter-se-merit as notified in the Prospectus and the choice of the station opted by the candidate at the time of counseling.
17. This is for the information of all candidates that as per Hon'ble Supreme Court of India, if any incident of ragging comes to the notice of the authority, the concerned student shall be given liberty to explain and if his explanation is not found satisfactory, the authority would expel him/her from the institution. Raging is prohibited in all forms.

This Prospectus is subject to alteration(s) or modification(s) at any time without notice.

The University will not be responsible for any delay or loss in transit caused by Postal Dept. /Courier Services or anyone else.
22. Notwithstanding the participation of candidates in counselling, only eligible candidates, as notified, shall be considered for admission.
23. Candidates applying under any of the reserve category are directed to fill the right category code mentioned in this prospectus for claiming reservation under a category and also attach all relevant documents/proof of respective category with admission application form and bring along the photocopies and original documents at the time of counseling/admission.

#### **ELIGIBILITY CONDITIONS:**

1. The **admission to** Allied Healthcare Science Courses shall be open to candidates who have qualified minimum eligibility criteria notified in the Prospectus.
2. Merely applying for admission on the basis of fulfilling minimum eligibility criteria will not entitle the Candidates for admission. The allocation of seat will be made after verifying the eligibility of the candidate by the admission committee strictly as per rules and regulations laid down by BFUHS /published in the prospectus.

In case of two or more candidates having equal marks then there inter-se merit will be on the basis of Age i.e Candidate older in age will be placed higher in merit.

### **Step-I SUBMISSION OF HARD COPY OF ADMISSION APPLICATION FORM AT PRINCIPAL OFFICE, ALLIED AND HEALTHCARE SCIENCE IN THE PREMISES OF GGS MEDICAL COLLEGE, FARIDKOT ALONG WITH THE FOLLOWING SELF- ATTESTED DOCUMENTS :**

- Passport size colour photograph (self-signed) of the candidate is to be affixed on the Admission Application Form.
- Punjab Residence Certificate.
- Matric or equivalent certificate for Date of Birth.
- Detail Marks card of Graduation or any other qualifying exam on the basis of which admission is sought.
- Degree of Graduation or any other qualifying examination
- Migration Certificate.
- Character certificate from Institution last attended.
- Reserved Category Certificate to be issued from the Competent Authority as given in Prospectus.
- Undertaking by the candidate for Gap year, in original, if any.
- Bank Demand Draft in Original.

  10. In all academic matters, the University is the final authority.
  11. Students claiming benefits of reservation under SC/ BC category shall be required to produce a certificate from the competent authority as per latest instructions of Govt. of Punjab. Further a valid backwards class certificate must be produced as per the latest instructions of Govt. of Punjab.
  12. The seats remaining vacant under any reserve category shall be transferred to General Category during subsequent round of counselling.
  13. The personal appearance of candidate is essential at the time of counselling. He/ She has to produce all documents/testimonials in original for verification by the selection committee, failing which he she will not be considered for admission during the Counselling.
  14. On Provisional Selection during the counselling, the candidates have to report to the Principal of concerned college up to the last date fixed for submission of joining after checking of eligibility and verification of original documents followed by the Medical check- up.
  15. Before the completion of admission process, if any candidate desires to surrender the seat, he/she may surrender the seat to the Principal of concerned college.
  16. The candidate can surrender the seat before the start of subsequent round of counselling.
  17. **Hostel facility is not available. If lateron hostel facility is made available, the hostel fee will be in terms of Punjab Govt. Letter No. 7/107/2012-5SS3/209 dated 11.02.2015.**
  18. The student will have to pay the Tuition Fee for all remaining years (as per duration of course), if he/she leaves the course/vacates the seat in midstream i.e. after the last/cut-off date of admission. The last /cut-off date for admission for the said courses is 30.11.2025 for admission session 2025.

The matter has been reconsidered in the light of judgement delivered by the Hon'ble Supreme Court of India in the case of Dr. Pradeep Jain Vs. Union of India and others reported as AIR 1984-SC-4121 wherein it was held that instead of the word 'Domicile' the word 'Residence' be used in the instructions issued by the State Government on the subject. Accordingly, it has been decided by the Government to revise the Government instructions referred to above as under:

**Subject: Bonafide Resident of Punjab Guidelines for grant of Residence Certificate**

With reference to letter No.1/3/95-3PII/9619, dated the 6th June, 1996 of this Department on the subject noted above and to say that keeping in view the hardship being faced by the Employees in getting the 'Residence Certificate' it has been decided to decentralize the powers of issuing the 'Residence Certificate' in process of the categories mentioned below:

**Categories:**

do -

- ii) Children/wards of
- a) The employees of Punjab Government posted in or outside Punjab State or working on deputation having at least 3 years of service.
- b) the employees of Government of India posted in Chandigarh or in Punjab in connection with the affairs of the Punjab Government for a period of 3 years.
- c) the employees of State Government institutions/undertaking who are posted in Chandigarh or in Punjab in connection with the affairs of the Punjab Government for a period of 3 years.
- d) the employees having at least 3 years of service in autonomous bodies/ companies in which Punjab Government has 20% or more shares.

- do -

The Heads of the office shall be competent to issue the requisite certificate to the employees with the exception that in the case of head of Office, the Head of the Department shall be the Competent Authority to issue the certificate

- do -

From: Chief Secretary to Government of Punjab to all the Heads of the department etc.

Subject: Issuance of certificate for the purpose of seeking admission to various educational/technical/professional institutions in the state and also for employment.

Sir,

It has been brought to the notice of Government that educational authorities and institutions prescribe various certificates regarding residence, SC/BC category and backward area etc. to be furnished by the students/candidates with the applications forms for entrance examinations or employment in the formats and by the authorities different from those prescribed by the Government departments. Cases have also been reported where the authorities concerned insist on retaining original certificates and refuse to accept the attested photo copies of the certificates. All this results in harassment and panic among the students/candidates and their parents/guardian, since they have to apply with such certificates to more than one authorities simultaneously and within a limited period. The lists of certificates required at the time of applying for CET/PMET/PMT and PAU are enclosed by way of illustration.

2. In order to overcome the difficulty mentioned above, it has been decided by the Government that following procedure has been decided by the Government that the following procedure shall be followed meticulously by all the educational and other authorities concerned:-

- i) Certificates issued in the format and by the authorities prescribed by the Government Departments shall be accepted as valid by all educational institutions and other authorities.
- ii) Where a number of authorities have been authorized to issue the certificates there shall be no insistence on issue of a certificate by any particular authority or by the highest authority indicated in the format.
- iii)(a) In case of entrance examinations, no certificate should be called for in the first instance alongwith the application form. It will be sufficient for the candidate seeking admission or other facility to indicate in the application form whether he/she belongs to any particular category entitling him/her to certain concessions or facility. Requisite certificates may be obtained only from the selected/wait listed candidates.
- iii)(b) To further simplify the procedure attested copies of the certificates only shall be retained and original certificates if required to be produced at the time of interview shall be returned immediately, thereafter.
- iv) Parents / guardian or candidates can also obtain SC certificates from the Head of the institution where the candidate has studied if the proof is available in the school records.
- v) The persons who are employed in Government of India or any other State Government are to be treated at par with the employees of the Government of Punjab in the matter of issue of Scheduled Caste certificate provided relevant Scheduled Caste certificate exists in their service record. The Scheduled Caste certificate in such will be issued by the respective Heads of Departments in the Proforma below:-

- vi) In case of, freedom fighters, political sufferer terrorists/riot victims and migrations where the registers are maintained by DC office, the certificate may be issued by Deputy Commissioner/GA to DC/ADC. These instructions shall come into force with immediate effect and shall be effective even where admission prospectus have already been printed following earlier instructions but entrance examination is yet to be hold or deadline for submission of forms is not yet over. These instructions may be brought to the notice of all concerned for meticulous compliance. The receipt of this letter may please be acknowledged.
