<u>Procedure for seeking admission to B.Sc.(Nursing) course under Foreign National Students (FN) Quota affiliated to the BABA FARID UNIVERSITY OF HEALTH SCIENCES, FARIDKOT, PUNJAB(INDIA)</u>

The following procedure of admission is as per Punjab Govt. vide its notification No. 5/7/2016-5HB-III/5322 dated 04.09.2020. Relevant Clauses of notification are as under:

(Clause 6.9)

Vacant seats under NRI quota will be offered to Foreign Nationals, If theses seats cannot be filled up from Foreign Nationals then these seats will be diverted to General Category candidates.

Eligibility criteria for State/University as well as Private Institutes

- 1. Candidate must be 17 years of age on or before 31st December 2020.
- 2. They should have passed in such qualifying examination as regular candidate from a recognized institution in the subjects of Physics, Chemistry, Biology and English individually and should have obtained 45% marks taken together in PCB at the qualifying examination i.e (10+2). Candidates seeking admission under Foreign National Student (FN) quota are not required to take PPMET but they must appear for counseling before the Selection committee.
- 3. **Equivalence certificate of 10+2:** Submission of Equivalence certificate from AIU is mandatory for foreign Nationals. Only those students who have qualified 10+2 with subjects Physics, Chemistry, Biology and English from foreign Universities or boards of Higher education recognized as equivalent by the "Association of Indian Universities (AIU), New Delhi " are eligible for admission to B.sc Nursing course.
- 4. **Student Visa:** Candidates must have 'Provisional Student Visa' from the Indian Mission abroad before admission and once he/she gets the confirmed admission, 'Student Visa' are obtained from FRO/FRRO, on their own.
- 5. Candidates shall also be required to obtain a Clearance Certificate from the Ministry of Health and Family Welfare, Nirman Bhawan, New Delhi.
- 6. **No Objection Certificate**: Candidates Shall also be required to obtain a Clearance Certificate/No Objection certificate from the Indian Nursing Council, New Delhi (INC).

Introduction:

- 1. Candidates seeking admission under the Foreign National Students (FN) category into any of the Govt./University/affiliated institutions of Baba Farid University of Health Sciences in B.Sc.(Nursing) course having cleared 10+2 school qualification in appropriate subjects i.e Physics, Chemistry, Biology and English from any of institution/ university/board etc. recognized and approved by the Government/University are eligible to apply.
- 2. Applicants are required to first apply to the University on prescribed forms for equation of their respective qualification and issue of **Eligibility Certificate**. After obtaining the Eligibility Certificate, candidates are required to **apply afresh to the University for seeking admission in State/University/Private colleges**.
- 3. All applications are required to be sent to the University at its official address Baba Farid University of Health Sciences, Sadiq Road, Faridkot 151203 (Pb.), INDIA on or before the last date of receiving of applications.
- 4. The physical presence of the candidates is compulsory at the time of counselling. Admission shall be strictly according to preference category wise merit as per the Punjab Govt. Notification and its amendments.
- 5. After selection the candidates will be required to deposit the prescribed fee as per instructions.
- 6. For date of counselling and other information please keep yourself updated by visiting our University website www.bfuhs.ac.in from time to time.

Procedure for getting Eligibility Certificate

Before applying for admission under Foreign National Student(FN) quota a candidate needs to seek Equivalence/Eligibility certificate from BFUHS by applying on prescribed application performa available from the University office on payment of Rs. 1000/-. The performa may be downloaded from the University website www.bfuhs.ac.in and it may be sent to the University alongwith fee of US\$ 300 for B.Sc.(Nursing) plus US\$ 25 being the cost of the application form in the shape of demand draft/cashier's cheque in favour of the Registrar, Baba Farid University of Health Sciences, Faridkot drawn on any bank payable in India.

The applicant has to attach following documents along with the application:-

- (i) Date of Birth Certificate.
- (ii) 10+1/ equivalent examination detailed marks certificate(s)(The certificate(s) must show the marks of Physics, Chemistry, Biology & English)
- (iii) 10+2/ equivalent examination detailed marks certificate(s)(The certificate(s) must show the marks of Physics, Chemistry, Biology & English)
- (iv) 10+2 Examination Equivalence certificate from AIU New Delhi.
- (v) Explanation Sheet of grades.
- (vi) Character/Recommendation Certificate from the Head of the Institution last attended.
- (vii) Certificate/Degree/Diploma having passed qualifying examination as a regular candidate from the recognized institution /university.
- (viii) Proof of Foreign National status of candidate.

- (ix) Clearance Certificate/No Objection certificate from the Indian Nursing Council (INC), New Delhi.
- (x) Clearance Certificate from the Ministry of Health and Family Welfare, Nirman Bhawan, New Delhi
- (xi) 'Provisional Student Visa' from FRO/FRRO.

Note:- These documents should be original along with photocopies duly self attested.

A candidate should fill in the form preferably in his/her own handwriting & send it to the Registrar, Baba Farid University of Health Sciences, Sadiq Road, Faridkot-151203 (Pb) India along with a Bank Draft for **US\$ 300 for B.Sc.(Nursing)** or equivalent amount in Indian rupees, in favour of the Registrar, Baba Farid University of Health Sciences, Faridkot, (Pb) India payable at Faridkot.. If the form is down loaded he/she also send **Rs. 1000/- or \$25/-** as a cost of form.

After verification of the documents, the university will issue Eligibility/Equivalency Certificate to the Eligible candidates only, and all original documents will be returned in person at the time of issue of Eligibility/Equivalency certificate.

2. <u>Procedure for admission to State/University/Private colleges</u>

- After getting the Eligibility Certificate from the University, the candidate has to apply for admission in Govt./University/Private colleges, on the prescribed Admission Application form to the Registrar, Baba Farid University of Health Sciences, Faridkot.
- The Admission Application form for admission is available at the University counter on a payment of Rs.2000/- or US \$ 50.
- The candidate can also obtain this form by post on request for which the candidate
 has to send a Demand Draft of Rs.2000 or US \$ 50 in favour of Registrar, Baba Farid
 University of Health Sciences, Faridkot drawn on any bank payable at Faridkot.
- The candidate can also download Admission Application form from the website of the University www.babafariduniv.com. However, if the candidate downloads the form from the Website, he will have to send an additional demand draft of Rs.2000/- or US \$ 50 in favour of Registrar, Baba Farid University of Health Sciences, Faridkot drawn on any bank payable at Faridkot towards the cost of this form.

After getting the Admission Application form, he has to send this duly completed form to Registrar, Baba Farid University of Health Sciences, Faridkot, along with a bank draft of **US\$ 300 for B.Sc.(Nursing)** or its equivalent amount in Indian Rupees in favour of Registrar, Baba Farid University of Health Sciences, Faridkot drawn on any bank payable at Faridkot.

Last date for receipt of Admission Application Form at university counter is 15.10.2020

The candidate has to attach the photocopies of the following documents duly attested by the competent authority along with application form:-

- (iii) (The certificate(s) must show the marks of Physics, Chemistry, Biology & English)
- (iv) 10+2/ equivalent examination detailed marks certificate(s)
- (v) (The certificate(s) must show the marks of Physics, Chemistry, Biology & English)
- (vi) Explanation Sheet of grades.
- (vii) Date of Birth Certificate.
- (viii) Character/Recommendation Certificate from the Head of the Institution last attended.
- (ix) Certificate/Degree/Diploma of having passed qualifying examination as a regular candidate from the recognized institution /university.
- (x) Eligibility certificate

- (xi) Three latest color signed and attested photographs (Passport size).
- (xii) The candidate applying under category (I) are required to submit
 - a. Photostat Copies of the passport of Father/Guardian/Candidate.
 - b. Proof of having ancestral background of Punjab.
- (xiii) Demand Draft/ Cashier's Cheque for **US\$ 300 for B.Sc.(Nursing)** or equivalent in Indian Rupee.

- (a) The student will have to give a bank guarantee/surety bond for the residual fee, if he/she opts to pay the fee in installment as provided.
- (b) Selected Candidates will have to deposit full/1st installment of the fee on the spot.
- (c) The payment in shape of Demand Draft should be in favour of Registrar, Baba Farid University of Health Sciences, Faridkot.
- (b) The payment should either be in US \$ or is drawn from their own or parents NRE account along with bank certificate/statement showing that payment is drawn from candidate or parents account.

- 4. Candidates shall also be required to obtain a Clearance Certificate from the Ministry of Health and Family Welfare, Nirman Bhawan, New Delhi in due course and submit it to the Principal of the college to which they are admitted.
