Admission Notice for NRI seats in Post Basic B.Sc.(Nursing) Course, Session 2020

Application for issuing of Eligibility certificate is available from the University counter/can be downloaded from University website.

Eligibility:

- b. Candidate should have passed GNM Nursing examination.
- c. Should be registered Nurse and Registered mid wife with any state nursing registration council.
- d. Candidate, who has passed qualifying examinations from foreign country, must submit a copy of approval from the Indian Nursing Council, Combined council Building, Kotla Road, Temple Lane, New Delhi-110002.

The admission shall be on merit determined on the basis of percentage of marks of Entrance test.

15% seats for private colleges and 7.5% seats for Government/University colleges of total seats are reserved for NRI's in Post Basic B.Sc.(Nursing) course in order to preference as under:

Category I: NRIs who are having ancestral Punjab Resident background.

Category II : NRIs who are having ancestral background of state of India other than Punjab.

- (I) Under this policy Non Resident Indian Means a person of Indian origin, whether holding an Indian Passport or Foreign Passport, who is either permanently or temporarily settled outside India and in either case:
 - (i) For or on taking up employment outside India; or
 - (ii) For carrying on a business or vocation outside India; or
 - (iii) For any other purpose, in such circumstances, as would indicate his intention to stay outside India for an uncertain period;

For ascertaining the eligibility relevant documents including Foreign Country Passport or Green Card or Permanent Resident Card or Proof of Residency of Foreign Country issued by competent authority or OCI/PIO Card issued by the Government of India Shall be taken into consideration.

The selection shall be made as per following manner, subject to the condition that the rules/regulations/guidelines of Indian Nursing Council are strictly followed:

- (i) From amongst the Entrance Test (PPBNET-2020) qualified students on the basis of merit list.
- (ii) From amongst the Entrance Test (PPBNET-2020) appeared students on the basis of merit list.
- (iii) From amongst the basis of merit of qualifying exam.

Procedure for admission to All University Colleges/Private colleges

- Form for getting Eligibility certificate from university website. Fee for getting eligibility certificate
 Rs. 1000/- in favour of Registrar, Baba Farid University of Health Sciences, Faridkot drawn on any bank payable at Faridkot towards the cost of this form.
- After getting the form, he has to send this duly completed form to Registrar, Baba Farid University of Health Sciences, Faridkot, along with a bank draft of US \$ 300 its equivalent amount in Indian Rupees in favour of Registrar, Baba Farid University of Health Sciences, Faridkot drawn on any bank payable at Faridkot.

- After getting the Eligibility Certificate from the University, the candidate has to apply for admission on the prescribed Admission Application form to the Registrar, Baba Farid University of Health Sciences, Faridkot.
- The candidate downloads the form from the Website, send an additional demand draft of **Rs.2000**/- in favour of Registrar, Baba Farid University of Health Sciences, Faridkot drawn on any bank payable at Faridkot towards the cost of this form.
- After getting the Admission Application form, he has to send this duly completed form to Registrar,
 Baba Farid University of Health Sciences, Faridkot, along with a bank draft of US \$ 300 its equivalent
 amount in Indian Rupees in favour of Registrar, Baba Farid University of Health Sciences, Faridkot
 drawn on any bank payable at Faridkot.
- Last date for receipt of admission application form at university is 15/10/2020.
