PROCEDURE FOR SEEKING ADMISSION TO POST BASIC B.SC.(NURSING) COURSE UNDER FOREIGN NATIONAL STUDENTS (FN) QUOTA AFFILIATED TO THE BABA FARID UNIVERSITY OF HEALTH SCIENCES, FARIDKOT, PUNJAB(INDIA), SESSION 2024

The following procedure of admission is as per Punjab Govt. vide its notification No. 5/21/2013-5HB-III/Spl dated 28/08/2021. Relevant Clauses of notification are as under:

(Clause 17 (VI)

Vacant seats under NRI quota will be offered to Foreign Nationals, If theses seats cannot be filled up from Foreign Nationals then these seats will be diverted to General Category candidates.

- 1. The selection shall be made as per following manner, subject to the condition that the rules/regulations/guidelines of Indian Nursing Council are strictly followed:
 - (i) From amongst the Entrance Test (PPBNET-2024) qualified students on the basis of merit list.
 - (ii) From amongst the Entrance Test (PPBNET-2024) appeared students on the basis of merit list.
 - (iii) From amongst the basis of merit of qualifying exam.

2. Eligibility Criteria:

- 1. Candidate must be 17 years of age on or before 31st December 2024.
- 2. Candidate should have passed GNM Nursing examination.
- 3. Should be registered Nurse and Registered mid wife with any state nursing registration council.
- 4. **Equivalence certificate of 10+2:** Submission of Equivalence certificate from AIU is mandatory for foreign Nationals. Only those students who have qualified 10+2 with subjects Physics, Chemistry, Biology and English from foreign Universities or boards of Higher education recognized as equivalent by the "Association of Indian Universities (AIU), New Delhi " are eligible for admission to B.sc Nursing course.
- 5. **Equivalence certificate of GNM:** Submission of Equivalence certificate from INC is mandatory for foreign Nationals. Only those students who have qualified from foreign University or boards of Higher education recognized as equivalent by the "Indian Nursing Council (INC) Combined council Building, Kotla Road, Temple Lane, New Delhi-110002 are eligible for admission to Post Basic B.Sc Nursing course.
- 6. **Student Visa:** Candidates must have 'Provisional Student Visa' from the Indian Mission abroad before admission and once he/she gets the confirmed admission, 'Student Visa' are obtained from FRO/FRRO, on their own.
- 7. Candidates shall also be required to obtain a Clearance Certificate from the Ministry of Health and Family Welfare, Nirman Bhawan, New Delhi.
- 8. **No Objection Certificate**: Candidates Shall also be required to obtain a Clearance Certificate/No Objection certificate from the Indian Nursing Council, New Delhi (INC).

PROCEDURE FOR GET ADMISSION TO ALL GOVERNMENT/UNIVERSITY/PRIVATE COLLEGES

• The candidate can download the application form for obtaining the eligibility certificate from the University website i.e. www.bfuhs.ac.in

- After getting the application form, he/she has to send this duly completed form to Registrar, Baba
 Farid University of Health Sciences, Faridkot, along with bank drafts of US \$ 300 its equivalent
 amount in Indian Rupees and Rs. 1000/- as cost of application form, in favour of Registrar, Baba
 Farid University of Health Sciences, Faridkot drawn from any bank payable at Faridkot.
- After getting the Eligibility Certificate from the University, the candidate has to apply for admission on the prescribed Admission Application form (available at University website) to the Registrar, Baba Farid University of Health Sciences, Faridkot.
- After getting the Admission Application form, he/she has to send this duly completed form to Registrar, Baba Farid University of Health Sciences, Faridkot, along with a bank draft of US \$ 300 its equivalent amount in Indian Rupees and Rs. 2000/- as cost of admission form, in favour of Registrar, Baba Farid University of Health Sciences, Faridkot drawn on any bank payable at Faridkot.
- Last date for submission of admission application form at university is 10/07/2024.

- (c) The payment in shape of Demand Draft should be in favour of Registrar, Baba Farid University of Health Sciences, Faridkot.
- (b) The payment should either be in US \$ or is drawn from their own or parents NRE account along with bank certificate/statement showing that payment is drawn from candidate or parents account.

- 3. Candidates must have 'Provisional Students Visa' from the Indian Mission abroad before admission and once he/she gets the confirmed admission, 'Students Visa' can be obtained from FRO/FRRO, on their own.
- 4. Candidates shall also be required to obtain a Clearance Certificate from the Ministry of Health and Family Welfare, Nirman Bhawan, New Delhi in due course and submit it to the Principal of the college to which they are admitted.
- 5. Candidates shall also be required to obtain a Clearance Certificate from Indian Nursing Council as per INC letter File Number: 7-2/2024-INC(Misc.) dated 16/05/2024 and submit it to the Principal of the college to which they are admitted.
