# Admission Notice for NRI seats in M.Sc.(Nursing) Course, Session 2023

The following procedure of admission is as per Punjab Government notification no.5/7/2013-5HB-III/5416 dated 09.09.2020. Relevant clauses of notification are as under:

Application for issuing of Eligibility certificate is available from the University counter/can be downloaded from University website.

#### **Eligibility:**

- a. Candidate should have qualified entrance test(PMNET-2023).
- b. Candidate should have passed B.Sc.Nursing/B.Sc.-Post Basic Nursing with minimum 55% marks.
- c. Should be registered Nurse and Registered mid wife with any state nursing registration council.
- d. Should have atleast one year work experience at the time of joining of the course
- e. Candidate after admission to M.Sc. Nursing course shall have to get registered with PNRC if already not registered with INC/PNRC.

The admission shall be on merit determined on the basis of percentage of marks of Entrance test. 15% seats for private colleges and 7.5% seats for Government/University colleges of total seats are reserved for NRI's in M.Sc.(Nursing) course in order to preference as under:

Category I: NRIs who are having ancestral Punjab Resident background.

Category II : NRIs who are having ancestral background of state of India other than Punjab.

- (I) Under this policy Non Resident Indian Means a person of Indian origin, whether holding an Indian Passport or Foreign Passport, who is either permanently or temporarily settled outside India and in either case:
  - (i) For or on taking up employment outside India; or
  - (ii) For carrying on a business or vocation outside India; or
  - (iii) For any other purpose, in such circumstances, as would indicate his intention to stay outside India for an uncertain period;

For ascertaining the eligibility relevant documents including Foreign Country Passport or Green Card or Permanent Resident Card or Proof of Residency of Foreign Country issued by competent authority or OCI/PIO Card issued by the Government of India Shall be taken into consideration.

#### Procedure for admission to All University/Private colleges

- 1. Date of Entrance Test is 14.07.2023.
- 2. After qualifying Entrance test (PMNET-2023), candidate will apply to university for Eligibility certificate.
- 3. Form for getting Eligibility certificate from university website. Fee for getting eligibility certificate **Rs. 2500**/- in favour of Registrar, Baba Farid University of Health Sciences, Faridkot drawn on any bank payable at Faridkot towards the cost of this form.
- 4. After getting the form, he has to send this duly completed form to Registrar, Baba Farid University of Health Sciences, Faridkot, along with a bank draft of **US \$ 500** its equivalent amount in Indian Rupees in favour of Registrar, Baba Farid University of Health Sciences, Faridkot drawn on any bank payable at Faridkot

- 5. After getting the Eligibility Certificate from the University, the candidate has to apply for admission on the prescribed Admission Application form to the Registrar, Baba Farid University of Health Sciences, Faridkot.
- 6. The candidate downloads the **Admission Application Form** from the University Website, send an additional demand draft of **Rs.3000/-** in favour of Registrar, Baba Farid University of Health Sciences, Faridkot drawn on any bank payable at Faridkot towards the cost of this form
- 7. After getting the Admission Application form, he has to send this duly completed form to Registrar, Baba Farid University of Health Sciences, Faridkot, along with a bank draft of **US \$ 500** its equivalent amount in Indian Rupees in favour of Registrar, Baba Farid University of Health Sciences, Faridkot drawn on any bank payable at Faridkot.

- (a) The student will have to give a bank guarantee/surety bond for the residual fee, if he/she opts to pay the fee in installment as provided.
- (b) Selected Candidates will have to deposit full/1st installment of the fee on the spot.
- (c) The payment in shape of Demand Draft should be in favour of Registrar, Baba Farid University of Health Sciences, Faridkot.
- (b) The payment should either be in US \$ or is drawn from their own or parents NRE account along with bank certificate/statement showing that payment is drawn from candidate or parents account.

- 2. Statements of result issued by School / College and the un-authenticated Result Notification / Result Slip etc. will not be accepted.
- 3. Candidates must have 'Provisional Students Visa' from the Indian Mission abroad before admission and once he/she gets the confirmed admission, 'Students Visa' can be obtained from FRO/FRRO, on their own.
- 4. Candidates shall also be required to obtain a Clearance Certificate from the Ministry of Health and Family Welfare, Nirman Bhawan, New Delhi in due course and submit it to the Principal of the college to which they are admitted.
