**NOTIFICATION**

No.1/70/2008-2HB3(PF-1)/2514

In partial modification of the notification no.1/70/2008-2HB3(PF-1)/1836 dated 10.04.2018 regarding Selection of Senior Residents following amendments are incorporated and notified :

**1. The Clause "A." "(a)" and "A." "(b)" is hereby substituted as below:-**

A. a) DM in super specialities of Cardiology, Endocrinology, Nephrology, Neurology, Medical Oncology, Gastroenterology, Neonatology;  
provided that in case of candidates of DM are not available, M.D./M.S. from allied specialities will also be eligible or,

b) M.Ch in Cardiovascular & Thoracic Surgery, Neurosurgery, Pediatric Surgery, Urology, Surgical Oncology;

provided that in case of candidates of M.Ch are not available, M.D./M.S. from allied specialities will also be eligible or,

**2. The Clause "B." "Category 1:" "(c)" is hereby substituted as below :-**

c) Maximum age must not be more than 40 years(as per Medical Council of India notification dated 05.06.2017);

provided that in case adequate eligible candidates of 40 years or below are not available, candidates above the age of 40 years will also be eligible.

Further provided that in case of Super specialities as mentioned in Clause "A." "(a)" and "A." "(b)" there shall be no age limit (as per Medical Council of India notification dated 05.06.2017).

**3. The Clause "B." "Category 2:" "(b)" is hereby substituted as below:-**

b) Maximum age must not be more than 40 years (as per Medical Council of India notification dated 05.06.2017);

provided that in case of adequate eligible candidates of 40 years or below are not available, candidates above the age of 40 years will also be eligible.

Further provided that in case of Super specialities as mentioned in Clause "A." "(a)" and "A." "(b)" there shall be no age limit (as per Medical Council of India notification dated 05.06.2017).

**4. The Clause "B." "Category 3:" "( b)" is hereby substituted as below:-**

- b) Maximum age must not be more than 40 years (as per Medical Council of India notification dated 05.06.2017);

provided that in case of adequate eligible candidates of 40 years or below are not available, candidates above the age of 40 years will also be eligible.

Further provided that in case of Super specialities as mentioned in Clause "A." "(a)" and "A." "(b)" there shall be no age limit (as per Medical Council of India notification dated 05.06.2017).

**5. The Clause "B." "Category 4:" " (c)" is hereby substituted as below:-**

- c) Maximum age must not be more than 40 years (as per Medical Council of India notification dated 05.06.2017);

provided that in case of adequate eligible candidates of 40 years or below are not available, candidates above the age of 40 years will also be eligible.

Further provided that in case of Super specialities as mentioned in Clause "A." "(a)" and "A." "(b)" there shall be no age limit (as per Medical Council of India notification dated 05.06.2017).

**6. The Clause "B." "Category 5 : " is hereby substituted as below:-**

**Category 5 : Other Service Candidates :** After filling seats from Category 1, 2, 3 & 4 remaining seats will be filled from the candidates from services other than PCMS doctors and from RMOs working in State of Punjab or Government of India. Maximum age must not be more than 40 years (as per Medical Council of India notification dated 05.06.2017) ;

provided that in case of adequate eligible candidates of 40 years or below are not available, candidates above the age of 40 years will also be eligible.

Further provided that in case of Super specialities as mentioned in Clause "A." "(a)" and "A." "(b)" there shall be no age limit (as per Medical Council of India notification dated 05.06.2017).

7. The Clause "B." "Category 6 : " is hereby substituted as below:-

**Category 6 : Others** : After filling seats from Category 1, 2, 3, 4 & 5 remaining seats shall be filled from the other candidates including freshly passed out post graduates. Maximum age must not be more than 40 years (as per Medical Council of India notification dated 05.06.2017) ;

provided that in case of adequate eligible candidates of 40 years or below are not available, candidates above the age of 40 years will also be eligible.

Further provided that in case of Super specialities as mentioned in Clause " A." "a)" and "A." "b)" there shall be no age limit (as per Medical Council of India notification dated 05.06.2017) .

8. Other policy directives and terms and conditions shall remains the same as per the Notification no.1/70/2008-2HB3(PF-1)/1836 dated 10.04.2018.
