- Note: 1. The above schedule is revised in view of the interim orders dated 06.07.2020 passed by Hon'ble Punjab and Haryana High Court in CWP No. 6554 & 8471 of 2020. The above schedule and process of counselling is subject to the final outcome of these CWPs. These CWPs are listed for hearing in Hon'ble Court on 15.07.2020. The decision of Hon'ble Court will be implemented in letter and spirit and if there is any change in the schedule, the same will be conveyed through university website.
  - 2. Display of allotment list for 2<sup>nd</sup> round of PG counseling will be as per orders of Hon'ble Punjab and Haryana High Court in CWP No. 7559 of 2020 which is listed in the Hon'ble Court for next hearing on 15.07.2020.
  - 3. The allotment of seats to PCMS In service candidates is also purely provisional subject to final outcome of the CWP 7559 of 2020.
  - 4. All the allotment of seats in the 2<sup>nd</sup> PG online counselling is purely provisional and subject to the final decisions in various writ petitions related to PG admissions, session 2020.
  - 5. The Hon'ble Punjab and Haryana High Court in CWP No. 7941 of 2020 titled as Adesh University & Anr. Vs. State of Punjab & Anr. ordered (operative part) on 18.06.2020 as under:

"Accordingly, operation of the Corrigendum dated 19.05.2020 (P-15) qua the petitioner-University is stayed. However, the petitioner-University shall file an affidavit in this Court before the second counselling, undertaking that incase the present petition fails, the petitioner-University will refund the excess of the fees charged from the students with interest at the rate of 7% per annum."

In view of the above interim orders of Hon'ble Court, the fee of Adesh Medical College, Bathinda will be as per fee structure prescribed by the Adesh University and the fee will be collected from the candidates to whom seats will be allotted at Adesh Medical College, Bathinda as per the fees which was collected at the time of 1<sup>st</sup> PG counselling.

- 6. Once the candidate has taken admission in 2nd round of State counseling, he/she will not be allowed to resign from his/her seat and will not be eligible for further round of counselling in compliance with the directions of Hon'ble Supreme Court of India dated 09/05/2017 passed in Writ Petition (c) no. 267 of 2017 Dar-Us-Slam Educational Trust & Ors. Vs MCI & Ors.
- 7. In view the various queries regarding conversion of vacant reserve category, NRI seats, Minority quota seats etc. In this regard this is to inform that after exhausting all candidates of respective category/quota, these seats will be converted into IP/general/open category of respective quota as per Punjab Government notification in 2<sup>nd</sup> round itself.

**B.** The following original certificates/ documents are required for Physical reporting/joining to be shown to the allotted College authorities:

## In view of the above the participating candidates are instructed as follows:-

- i) Admit card issued by NBE
- ii) Result/Rank Latter issued by NBE.
- iii) Mark Sheets of MBBS/BDS 1<sup>st</sup>, 2<sup>nd</sup> & 3<sup>rd</sup> /Final Professional Examinations.
- iv) MBBS/BDS Degree Certificate/Provisional Certificate.
- v) Internship Completion Certificate/Certificate from the Head of Institution.
- vi) Permanent / provisional Registration Certificate issued by MCI or DCI/State Medical or Dental Council.
- vii) High School/Higher Secondary Certificate/Birth Certificate as proof of date of Birth.
- viii) Candidates allotted seat must carry one of the identification proofs (ID Proof) to the allotted college at the time of admission (as mentioned in the information Bulletin published by the National Board of Examinations (NBE) for AIPGMEE/AIPGDEE i.e. PAN Card, Driving License, Voter ID, Passport or Aadhar Card.)
- ix) The Candidate should also bring/ upload the following certificate if applicable.
  - a. SC Certificate issued by the competent authority of Punjab.
  - b. BC certificate issued by the competent authority of Punjab. The BC certificate must be in the format as mentioned in the prospectus.
  - c. Disability Certificate issued from duly constituted and authorized Medical Board for 21 Benchmark Disabilities as per the Rights of Persons with Disability Act,2016 as mentioned in the Information Bulletin for National Eligibility-cum-Entrance Test (Post Graduate) NEET-PG-2020. No other PWD certificate, issued by any other Authorities/ Hospital will be entertained.
  - d. The EWS certificate issued by the competent authority of Punjab.
- x) The undertaking mentioned in the Prospectus as Annexure B or Annexure C.
- xi) The candidates selected at CMC Ludhiana under category B Service Commitment will submit the requisite eligibility certificates/undertakings as mentioned in the prospectus of CMC/CDC, Ludhiana in the respective college.
- xii) The candidates selected at SGRD Amritsar in Sikh Minority Quota, will submit the requisite eligibility certificates/undertakings as mentioned in the prospectus of SGRD, Amritsar in the respective college.
- xiii) Hand Written and Self Attested Undertaking by the candidate stating as under:-
  - "I hereby declare that all the information given/uploaded by me in the application is factually correct and true to the best of my Knowledge and belief. I undertake that in the event of any information being found false or incorrect at any stage, my candidature is liable to be cancelled and I will have no claim on the seat allotted to me by the competent authority".
- xiv) All admissions made online will be deemed Provisional, to be confirmed subject to **verification of documents** at the time of physical joining.
- xv) Email ID/ Phone Number of the Principal/ Nodal officer of allotted college will be displayed on university website.
