

## Instructions to Provisionally selected candidate

1. You are required to report to the respective allotted college up to **04.05.2020** as under :

### 1) Physical Reporting

You can report to the college physically for taking admission, after paying necessary six months fees through RTGS/NEFT to the account of university notified on university website and submission of the original documents at the college and start duties.

### 2) Online Reporting

You can join the allotted college by sending a confirmatory email regarding acceptance of seat and uploading scanned copies of relevant documents as mentioned in important questions related to scheme of counseling and pay the requisite six months fees through RTGS/NEFT to the account of university, notified on university website.

The Email ID of respective allotted college will be provided on their respective website to upload the documents in case of online reporting.

### Instructions to provisionally selected candidates for deposition of fee

1. The provisionally selected candidates are requested to deposit the requisite six months tuition fee only after receiving the SMS for the same.
2. The candidates are directed to deposit the six month fee in the form of NEFT/RTGS transfer to the University Account and send the scanned copy of the receipt to the respective allotted institute mentioning the transaction ID/UTR clearly.
3. The details of the Bank Account in which fee is to be deposited is as below :

4. The Provisional Selection Slip will be generated only after the confirmation of deposition of fee.

**Note : In case you are failed to report for joining by 04.05.2020, the provisional seat allotted to you will be treated as cancelled and no claim thereafter will be entertained in any case.**

2. You are required to keep following documents ready for joining :

- i) Admit card issued by NBE
- ii) Result/Rank Letter issued by NBE.
- iii) Mark Sheets of MBBS/BDS 1<sup>st</sup>, 2<sup>nd</sup> & 3<sup>rd</sup> Professional Examinations.
- iv) MBBS/BDS Degree Certificate/Provisional Certificate.
- v) Internship Completion Certificate/Certificate from the Head of Institution.
- vi) Permanent / provisional Registration Certificate issued by MCI or DCI/State Medical or Dental Council.
- vii) High School/Higher Secondary Certificate/Birth Certificate as proof of date of Birth.
- viii) The NOC from competent authority in case of PCMS candidates.
- ix) One of the identification proofs (ID Proof) i.e. PAN Card, Driving License, Voter ID, Passport or Aadhar Card.)
- x) Reserve category certificate in case of seat allotted in SC/BC/EWS/PWD category.
- xi) The undertaking mentioned in the Prospectus as Annexure B or Annexure C.
- xii) Relevant documents/proofs of Minority Quota in case your selected is in Sikh/Christian Minority Quota as required by the allotted college. In case the candidates opt for online reporting, the final decision regarding eligibility for Sikh Minority status will be decided at the time of physical reporting by SGRD Medical/Dental College, Amritsar
- xiii) Proof of deposition of six months fees to the Registrar, BFUHS, Faridkot through RTGS/NEFT online mode in the university account.
- xiv) Your selection is purely provisional subject to **verification of original certificates/documents** at the time of physical joining by the allotted college.
- xv) Self attested hand written undertaking in the following format :
  1. That I was selected through All India Quota counselling in the \_\_\_\_\_ college in the \_\_\_\_\_ speciality.  
OR
  2. That I was selected through State Quota counselling (other than Punjab) in the \_\_\_\_\_ college in \_\_\_\_\_ speciality in \_\_\_\_\_ State.  
OR
  3. That I was not selected in any college in any counselling of All India / State.
- xvi) If you have been allotted seat in All India 1<sup>st</sup> Counselling under NEET PG 2020, you will have to resign from All India Quota seat and submit the proof of resignation of All India Quota seat in the allotted college at the time of joining.
- xvii) Hand Written and Self Attested Undertaking by the candidate stating as under:-

**“I hereby declare that all the information given/uploaded by me in the application is factually correct and true to the best of my Knowledge and belief. I undertake that in the event of any information being found false or incorrect at any stage, my candidature is liable to be cancelled and I will have no claim on the seat allotted to me by the competent authority”.**
