

**Detailed Schedule for 3<sup>rd</sup> round of PG Medical/Dental online Punjab State counseling under NEET PG-2023.**

1.	Date for fresh online registration/application and deposition of application and security deposit for fresh applicants alongwith fee of Rs. 5000+18%GST( <b>Rs. 5900/-</b> ) and Rs. 2500+18%GST( <b>Rs. 2950/-</b> for SC candidates) through university payment portal. (Fresh registered candidates will have to submit willingness alongwith security deposit for 3 <sup>rd</sup> online counseling, failing which their candidature will not be considered. <b>Note: The candidate who has not joined/resigned the allotted seat of Round 2, will have to register afresh for 3<sup>rd</sup> round and will also deposit security amount again.</b>	14.09.2023 to 17.09.2023 (upto 05:00pm)
2.	Display of link for tentative vacancy position of seats. Note: The vacancy position of seats will be automatically updated in case any candidate of round-1/2 will surrender the seat (exit with forfeiture) upto 19.09.2023 by 4.00PM.	Upto 15.09.2023
3.	<b>The dates for submitting willingness alongwith security deposit for 3<sup>rd</sup> round of counselling by all the candidates (already registered candidates and fresh applicants).</b> The amount of security to be deposited for submitting willingness will be as under : For Government colleges - Rs. 25000/- (half for SC/BC) For both Govt. & Private Colleges – Rs. 2,00,000/- For Private Colleges – Rs. 2,00,000/- <b>Note: The live vacant seat matrix will be displayed on the Student Login Id</b>	14.09.2023 to 18.09.2023
4.	Last date of correction/editing in online filled application form. Thereafter application will be locked automatically. Once information filled and locked, will not be allowed to change in any round of counselling. <b>Note : Since, fresh applications are invited for 3<sup>rd</sup> round of online counselling under NEET PG-2023 from 14.09.23 to 17.09.23, hence already registered candidates of 1<sup>st</sup>/2<sup>nd</sup> round counselling (if any) who intends to edit any Category/Minority Quota/other particulars will give request/application personally in the Admission Branch, BFUHS upto 17.09.2023 alongwith relevant proof for consideration in 3<sup>rd</sup> round of online counselling as last chance. No request shall be entertained through email. Thereafter no request will be entertained.</b>	17.09.2023
5.	Last date for submitting admission application form for <b>NRI quota</b> (Application form for getting Eligibility certificate and admission application form for NRI candidates is separately available on University website)	18.09.2023
6.	The candidates who will apply under Sikh Minority/Christian Minority Quota will report to the respective minority institution (SGRD Institute of Medical Sciences, Amritsar / Christian Minority College, Ludhiana) for verification of minority status. The candidates who have already got verified their minority status at the time of 1 <sup>st</sup> & 2 <sup>nd</sup> counseling, need not report to the respective institute for verify again. The candidates who have already registered under Minority Quota during 1 <sup>st</sup> & 2 <sup>nd</sup> counseling and did not get their minority status verified, can report to the respective institute for verification of their minority status for 3 <sup>rd</sup> round of counseling.	19.09.2023 upto 2.00 PM

12.	<b>In case there is any change in provisional allotment after considering objections, the same will be displayed through university website on</b>	Upto 29.09.2023
13.	The provisionally selected candidates will pay the balance amount of fee (Six month fee after deducting amount of security deposit) through university payment gateway available on university website and will report to the respective college for joining in the respective allotted college.	30.09.2023 to 01.10.2023

Note :

- Only inservice doctors who have rendered minimum one year regular service upto 31.03.2023 as per Punjab Govt. notification are eligible for **admission to DNB Courses** i.e. doctors who are working as PCMS, Rural Medical Officers in department of Rural Development, doctors in Municipal Corporations under the Department of Local Bodies and doctors working in various Boards and Corporations of Punjab Govt. If any candidate will submit wrong data while submitting online preferences regarding eligibility for DNB course or wrongly submit that he/she is in service candidate and the seat to whom will be allotted on submission of wrong information then he/she will not be allowed to join and will be debarred for further rounds of counselling. The security deposit of such candidates will also be forfeited on account of wrong information.
- For ensuring faithful obedience of time schedule and also keeping in view the limited time available for conducting counselling, all participating institutes / colleges are directed to treat all Saturdays and Sundays and Gazetted Holidays as working days.

### Eligibility for 3rd Round of Counseling :

- **The candidates who can apply afresh for 3rd Round of counseling (These candidates have to pay registration fee and security amount at the time of submission of willingness as per rules)**
    - The candidates who will register/apply for the first time.
    - The candidates who have not joined the allotted seat (fresh/upgraded) of Round-II counseling can apply afresh for 3rd Round and they will have to deposit security amount again for submitting willingness and choices/preferences of Course/College/speciality as per schedule.
    - The candidates who exit with forfeiture in round 2 can participate in 3<sup>rd</sup> Round but with fresh payment of fee i.e. fresh registration and security deposit.
    - The joined candidates of 1<sup>st</sup>/2<sup>nd</sup> Round and wants to upgrade in 3<sup>rd</sup> Round.
  - **The candidates who need not to apply afresh for 3rd Round of counseling**
    - The candidates who are already registered but have not been allotted any seat in Round I and II need not to register/apply again.
    - The candidates who have resigned/surrendered the allotted seat of 1<sup>st</sup> online Counseling with free exit upto 09.09.2023 by 2.00PM. However, they will have to submit Willingness alongwith requisite amount of security (equivalent to penalty) and will submit Choices/preferences of Course/College/speciality as per schedule.
  - **The candidates who are not eligible for 3<sup>rd</sup> Round of allotment.**
    - Candidate who has become non-eligible due to having inadequate documents as per Eligibility Criteria.
    - Candidate who has not registered in Round 1 or Round 2 or Round 3.
    - The already registered candidates of Round 1 or Round 2 or Round 3 who will not submit willingness to participate in Round 3 counselling .
    - The candidates who have joined the Round 1 or Round 2 of Punjab state counselling and who will not submit willingness to participate in Round 3 counselling.
    - The candidates who have joined the seat of Round 1 or Round 2 or Round 3 of AIQ as per list to be provided by the MCC.
- Note:** **Already registered candidates who have deposited security amount in 2<sup>nd</sup> round counselling and to whom no seat is allotted in 2<sup>nd</sup> Round, need not to deposit security amount again. However, they will have to submit willingness to participate in 3<sup>rd</sup> Round, through online payment gateway of University.**

### Frequently Asked Questions(FAQs) for 3<sup>rd</sup> Round of State Counseling for admission under NEET PG-2023

- 1 Ques:** **Whether the candidate who has joined the allotted college of Round-I & 2 can upgrade his/her seat during Round-3?**
- 1 Ans:** The candidate who is interested to participate/upgrade his/her seat in Round-3 will have to submit willingness for Govt. Colleges only / Govt. & Private Colleges(both) or Private Colleges only alongwith security fee equivalent to the penalty amount :
- Note:** The candidate has to submit the fresh choices/preference of Course/College during 3<sup>rd</sup> Round of online counseling.
- 2 Ques:** **Whether the willingness fee has to be deposited again to participate in Round 3, if no seat has been allotted during 2<sup>nd</sup> Round?**
- 2 Ans:** Not required. However, the candidates will have to submit willingness as per schedule to participate in 3<sup>rd</sup> round.
- 3 Ques:** **Whether the tuition fee paid at the time of joining in the provisionally allotted college during 1<sup>st</sup>& 2<sup>nd</sup> Round will be adjusted against the willingness fee for participating in Round-3?**
- 3 Ans:** The candidates who have already deposited fee during 1<sup>st</sup> & 2<sup>nd</sup> round equivalent to the security amount, need not to deposit the requisite fee, provided no penalty would have been imposed, otherwise remaining (proportionate) amount is required (as applicable).
- 4 Ques:** **Whether it is mandatory for the candidate to report to the provisionally allotted college of Round 3?**
- 4 Ans:** Mere paying the requisite amount of fee does not confer his/her right to the provisional allotment. The candidate who is interested to join the college shall pay the tuition fee and report to the concerned provisionally allocated college. If the candidate does not join the allotted seat of Round 3 the penalty will be imposed and the security amount deposited will be forfeited as per rules and elimination (ineligible to participate in any further round).
- 5Ques:** **Whether the candidate can surrender/leave/resign his/her the seat after joining the allotted college of Round-3?**
- 5Ans:** Once, the candidate joined the seat **will not be allowed to vacate** from allotted 3<sup>rd</sup> round seat.
- 6Ques:** **When will conversion of seats to open merit be carried out?**
- 6Ans:** The conversion of seat of NRI and reserve category after exhausting all candidates in relevant category will be carried out during the 3<sup>rd</sup> round. The said conversion will be done only when the eligible candidates belonging to the said conversion category have exhausted. In this regard, it is made clear that during 3<sup>rd</sup> round online counseling one can upgrade/shift seat as per his/her choice. Therefore, any seat may become vacant during the process of 3<sup>rd</sup>

round online counselling due to shifting /conversion of seats. Hence it is not mandatory to submit only those choices/ preference which are reflected in the vacancy position of seats. Therefore, candidates can submit preferences/choices for seats which are not reflected in vacancy position of seats.

**7Ques: Whether tuition fee can be paid through Demand Draft or Cheque?**

**7Ans:** Demand Draft or Cheque is not accepted. The applicant will pay the fee only through University payment gateway.

**8 Ques: Whether the candidate can claim his/her right to the concerned allotted seat if he/she does not join the concerned allotted seat within stipulated date and time of reporting/joining?**

**8Ans:** The candidate who will not report/join the provisionally allotted college within stipulated date and time, he/she cannot claim his/her right for the particular allotted seat and resultantly the vacant seat will be added in the vacancy position for next Round. Moreover, the penalty will be imposed and the security amount deposited will be forfeited as per rules.

**9.Ques: The candidate who do not join the allotted seat, whether he/she will be considered for further round of counseling(s).**

**9 Ans:** Once, the seat will be allotted during Round 3, the candidate will not be eligible to participate in Stray Vacancy Round or further rounds of counseling.

**10Ques: Whether the tuition fee can be adjusted if the seat is upgraded in the Round-3 Counseling?**

**10Ans:** Yes, the tuition fee will be adjusted (except the penalty amount, if any) and the candidate has to pay the remaining partial amount of tuition fee if required or the excess amount of fee paid will be refunded.

**11 Ques: Whether the candidate who is holding the seat will not submit joining in the new college on the upgraded seat allotted during Round-3 can claim his/her right on the previous seat allotted during Round-I or II?**

**11 Ans:** Once, the seat gets upgraded in Round-3, the previous gets vacated automatically and offered to the candidate as per merit in the same round. Thus, no claim can be made on the previous seat.

**12 Ques: What are the circumstances wherein the refundable security deposit will be forfeited?**

**12 Ans:.** Under the following circumstances the refundable security deposit will be forfeited:

i. Where a Candidate has been allotted a seat in Round 2 or subsequent rounds (round3, stray vacancy/further rounds) and does not report/joins at the allotted college to complete the admission process.

ii. The Security Deposit will be forfeited if the admission gets cancelled after allotment due to any reason. E.g., in case the candidate gives wrong information at the time of registration on the basis of which a seat may be allotted and later cancelled by the Admission Authorities at the time of reporting or fails to produce the required documents at the time of admission.

iii. where any joined candidate of 1<sup>st</sup> Round surrenders the seat after the lapse of time for free exit.

iv. where any joined candidate of 2<sup>nd</sup> Round surrenders the seat.

Note : Any Round 2 candidate who wants to resign may exit with forfeiture upto 19.09.2023 by 4.00 PM i.e. before the Choice Filling of Round-3 starts. There will be no option of resignation after 19.09.2023 (4.00 PM).

**13 Ques: Whether the candidates who have not joined/ surrendered the seat of 2<sup>nd</sup> Round are eligible for 3<sup>rd</sup> Round counselling?**

**13 Ans:.** The candidate who has not joined/resigned the allotted seat of Round 2, will have to register afresh for 3rd round and will also deposit security amount again.

**14 Ques: Whether I need to surrender the already joined seat of Round1/Round2 for participating in Round3 counselling?**

**14 Ans:.** The candidates who have already joined the Round 1/Round 2 seat and wants to participate in Round 3 for up-gradation/shifting of seat from one College/Course/Quota to another College/Course/Quota, **they need not to surrender the earlier seat.** But after the start of choice filling of Round 3, the joined candidate of Round 1/Round2 cannot surrender the seat, whether his/her seat is upgraded or not in the 3<sup>rd</sup> Round.
