

**Subject : Revised schedule for 3<sup>rd</sup> round of PG Medical online Punjab State counseling under NEET PG-2024. Date 17.01.2025.**

1.	The fresh online registration/applications alongwith fee of Rs. 5900/- (Rs. 2950/- for SC/BC) including GST through university payment portal are invited through University website only from candidates who became now eligible as per the Govt. of India, DGHS, New Delhi, MCC vide Ref. U-12021/05/2024-MEC dated 04.01.2025 vide which the qualifying percentile for admission under NEET PG-2024 is lowered/revised.	18.01.2025 (upto 5.00PM)
2.	Fresh registered and already registered candidates will have to submit willingness alongwith security deposit for 3 <sup>rd</sup> online counseling, failing which their candidature will not be considered. The amount of security to be deposited for submitting willingness will be as under : For Government colleges - Rs. 25000/- (Rs. 10000 for SC/BC) For both Govt. & Private Colleges – Rs. 2,00,000/- <b>Note: 1. The live tentative vacant seat matrix is available on University website</b> <b>2. Candidates are advised to check their name in the live willingness list displayed on the University website.</b>	18.01.2025
3.	<b>Last date for Surrender of seat by the joined candidates of 1<sup>st</sup>/2<sup>nd</sup> round with forfeiture of security deposit/fee</b> <b>Note: 1. The vacancy position of seats will be automatically updated in case any candidate of round-1<sup>st</sup> /2<sup>nd</sup> will surrender the seat.</b> Candidates are advised to see the updated vacancy position through University website. 2. The joined candidates of 1 <sup>st</sup> /2 <sup>nd</sup> round who have already submitted willingness to participate in 3 <sup>rd</sup> round and thereafter surrendered the seat <b>upto 22.01.2025</b> , will have to deposit the security deposit & fee again as security deposit & fee deposited by them will automatically be forfeited. Such candidates will have to report to the University personally <b>upto 23.01.2025</b> for depositing remaining fee and security deposit. In case their security deposit/fee is not received, they will not be considered for choice filling.	22.01.2025

8.	The last date/time of submission of objections to provisional allotment (if any) by the NEET PG aspirants. Objections can be submitted through email <a href="mailto:pgadmissionsbfuhs@gmail.com">pgadmissionsbfuhs@gmail.com</a> alongwith supporting documents.	01.02.2025
9.	In case there is any change in provisional allotment after considering objections, the same will be displayed through university website on	02.02.2025

The provisionally selected candidates will pay the balance amount of fee (Six month fee after deducting amount of security deposit) through university payment gateway available on university website and will report to the respective college for joining in the respective allotted college.	03.02.2025 to 05.02.2025 (Upto 5.00PM)

Note : The PCMS in service candidates, who wants to avail incentive marks, will submit the NOC duly issued by the Secretary to Govt. Of Punjab, Deptt. Of Health and Family Welfare/competent authority, personally in the University **on 20.01.2025 by 11.00AM**. In case, NOC is not received in University **on 20.01.2025 by 11.00AM**, the candidate will not be considered for incentive marks.
