- 2. This is to inform you that notification issued by Govt. of Punjab. Department of Medical Education (Health-III Branch) vide No. 5/26/2026-5 HB-III/423 dated 06.03.2023 published by Baba Farid University of Health Sciences, Faridkot on 20.11.2024 for the admission to MD/MS 2024 has been challenged by this university in the Hon'ble High court of Punjab and Haryana, vide CWP-32064-2024 (O&M) for fixation of fee as prescribed by Adesh University in its prospectus for admission to MD/MS.
