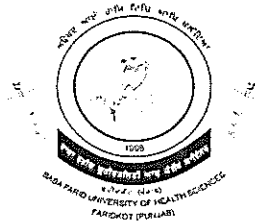



While going through the Action Taken Report **para-26**, the House noted that the following amendments in para 5.3(c) regarding Appointment of Supervisor of Ordinances, Rules/Regulation of Ph.D. (Nursing Sciences) has been recommended by the Faculty of Nursing Sciences to the Academic Council:

Clause 5.3(c)

Eligible Post Graduate Teacher (Non-Ph.D.) having postgraduate qualification with 10 year teaching experience after Post Graduation may be appointed supervisor and co-supervisor.

BE SUBSTITUTED as follows:



Eligible Post Graduate Medical Teacher having postgraduate qualification with 10 year teaching experience after Post Graduation may be appointed supervisor and co-supervisor.

After some discussion it was **RESOLVED**: Being PhD. in the discipline of nursing sciences, the Post Graduate medical teacher be considered as co-supervisor.


Further, it was **RESOLVED**: To recommend to the Academic Council for approval of the following amendments in para 5.3(c) regarding Appointment of Supervisor of Ordinances, Rules/Regulation of Ph.D. (Nursing Sciences):

"Eligible Post Graduate Medical Teacher having postgraduate qualification with 10 year teaching experience after Post Graduation may be appointed co-supervisor."

6. Considered the recommendations made by the Board of Studies of Nursing Sciences in its meeting held on 10.11.02017 vide para-6 and **RESOLVED**: To approve the panel of Internal Examiners the conduct of B. Sc (Nursing) examinations session November/December, 2017 with subject to the following conditions and amendments as under (**Pages 1 to 36 of Appendices**):

- 1) That while submission of list of proposed internal examiners the Principal(s) will clearly indicate the experience of each faculty member after passing M.Sc.(N) examination and a faculty member having minimum one year teaching experience after M.Sc. Nursing will be considered eligible for appointment as Internal Examiner at the time of examination/s and if somebody has less than one year experience after M.Sc. so he/she is not eligible Internal Examiner
- 2) That in case a relative of examiner is appearing, examiners retirement/transfer/marriage of examiner/Govt. job of examiner/court case/dispute, debarred, etc., the Principal of concerned college(s) will make prior request before the examination to the Controller of Examinations for appointment of Internal Examiner for B.Sc. (Nursing)/Post Basic B.Sc. (Nursing) and M.Sc. (Nursing) examinations and University is authorized on behalf of the Board/Faculty to take final decision in this regard.


That in case for the conduct of B. Sc (Nursing) and Post Basic (Nursing) examinations, if somebody has M.Sc. teacher but has < 01 year of teaching experience after M.Sc. or is fresher, the Principal of concerned college(s) will ensure that the teacher fulfill the eligibility criteria to act as Internal Examiner before the start of examination. Else the Principal of concerned college(s) will make prior request to the Controller of Examinations for appointment of internal examiner and University will take final decision



- 3) That Internal Examiner should have same specialty of M.Sc. (Nursing) except in the subject of Nursing Foundations for B. Sc (Nursing) and Post Basic (Nursing) examinations.
- 4) That the Principals should not recommend the name of more than one examiner for each subject in the list of internal examiners.
- 5) That some colleges have no eligible teacher to become Internal Examiners in various subjects as noted in the list already supplied by the concerned colleges, and a serious view of it has been taken and suggested that every college should have its own teacher to act as Internal Examiner as under:
 - a) That in case, if at the last moment, a request is received from the Principal for change of Internal Examiner due to non availability of Internal Examiner approved by the Faculty of Nursing Sciences, an alternate Internal Examiner will be appointed by the Controller of Examinations, after getting approval from the Competent Authority with a condition that University will charge Rs.1.00 lac per examiner from the College on account of penalty for not having its own Internal Examiner at last moment.
 - b) That in case, if the name of Internal Examiner is not given by the concerned college in the meeting of Board of Studies and further in the meeting of Faculty of Nursing Sciences; an Internal examiner will be appointed by the Controller of Examinations, after getting approval of the Competent Authority with a condition that University will charge Rs.1.00 lac per examiner from the College on account of penalty for not having its own Internal Examiner.
 - c) In both the cases (a) & (b) above, penalty is for consecutive 03 (Three) examination sessions. Thereafter the penalty will increase to double of its amount every consecutive examination session.
