Terms and Conditions:

- 1. Candidate for all the above mentioned posts can apply on deputation basis also as per Punjab Govt. Rules.
- 2. The pay scales for all posts will be given as per 7th CPC.
- 3. Fixed emoluments will be paid during probation period as per Punjab Civil Service Rules (Volume-1, Part-I) under Clause No. 4.1(1) and Department of Personnel, Govt. of Punjab vide letter no. 7/204/2012-5fp1/66 dated 15/01/2015 and its amendments issued from time to time, except for posts of Registrar, Dean (College Development) and Controller of Examination.
- 4. **Knowledge of Punjabi**:- That candidate must have passed Punjabi upto Matriculation or its equivalent level and in case he does not must acquire the same within six months of joining.
- 5. **Upper age limit: A)** The upper age limit for posts of Dean (College Development) and Controller of Examination is 50 years.
 - B) For all other posts the maximum age is 37 years.

Note: Relaxation in upper age limit as per Punjab Govt. Rules.

- 6. The Registrar shall hold office for a period of four years and shall be eligible for re-appointment for a further period of four years. Provided that no person appointed as Registrar shall hold office on attaining the age of 60 (sixty) years.
- 7. The qualification/experience of candidates should be prior/upto the last date of filling the applications and candidates should have to submit/upload the relevant certificates.
- 8. No TA/DA will be paid for the journeys performed for the Interview or written test/counseling/document verification etc.
- 9. University has no any mechanism to check the certificates of candidates who are applying online. If, at any stage certificate of the candidate is found fictitious / bogus or ineligible, the candidature of the candidate will be cancelled and action will be taken according to law.
