As per the directions of Government of Punjab, Department of Medical Education and Research, Punjab, Baba Farid University of Health Sciences, Faridkot conducted recruitment test for 411 posts (300 posts for Government Medical College Amritsar and Patiala and 111 posts at Dr. B.R. Ambedkar state Institute of Medical Sciences, Mohali) of Staff Nurse on 21-06-2020 at various centers in state of Punjab. Candidates are required to attend the document verification for checking of eligibility, original certificates. Keeping in view number of posts in each category, the candidates are called accordingly. Where the marks obtained by the candidates in the written test are same, the inter-see merit is determined by way of Date of Birth. If the number of candidates are found to be insufficient then next candidates in merit shall be called for verification.

Note:

1. List of candidates called for document verification as per above schedule is enclosed.
2. In case candidates having equal marks in written test, inter-see merit is prepared on the basis of candidate's date of Birth, candidate older in age placed before younger candidate.
3. Candidates equivalent to posts are called for document verification.

Important Instructions

1. The candidates are required to bring **original documents** comprising application fee receipt, Admit Card cum Roll No Slip, Photograph, experience, Age Proof, Proof of Punjabi passed at Matric level, Academic certificates, Caste certificate, Category certificate, Residence certificate etc along with photocopy of all testimonials. No separate correspondence shall be made in this regard by the University. Personal appearance of candidates is mandatory

during document verification. Counseling fee of Rs. 1000/- (Rs. 500/- for SC) shall be charged from each candidate on the spot at counseling venue.

2. Candidate shall download e-pass from State Government COVA App to reach the document verification center.
3. Candidate must fulfill the eligibility criteria for the post mentioned above.
4. In case, any certificate/testimonial of any applicant is found to be fake at any stage of recruitment or issued by an incompetent authority, the eligibility/appointment would be cancelled with immediate effect and legal action may be taken against him/her.
5. Appearance for document verification does not imply that candidate has fulfilled the entire criteria and he/she is eligible for the post. Eligibility of the candidate will be determined after through scrutiny of the application. If candidate is found not eligible by the document verification committee, his/her candidature will be cancelled.
6. Candidate will not be paid any TA/DA for attending the document verification
7. Keeping in view of situation of COVID-19, following advisory is issued for compliance.
 - a. **Due to situation of COVID-19, candidates should not be accompanied by more than one person.**
 - b. Wearing of face mask by all candidates is mandatory during appearance in document verification
 - c. Social distance i.e. minimum 4-6 feet as per the guidelines of Government of India must be maintained.
 - d. Thermal screening of each candidate is mandatory.
 - e. Candidates are allowed to carry their own drinking water.
 - f. Candidates are required to bring their own hand sanitizer.
 - g. Any candidate having any symptoms of COVID-19 or under going Quarantine/isolation period shall report separately.
 - h. Candidates shall take all the preventive/precautionary measures as advised by Government of India by time to time.
