Revised Admission Notice for Mop Up round for PG Medical courses under NEET PG-2021

The Govt. of India, Ministry of Health and Family Welfare vide letter F.No. U.12021/21/2022-MEC dated 12.03.2022 has lowered the qualifying percentile under NEET PG-2021 as under :

In order to facilitate freshly eligible candidates who became eligible after lowering of percentile to do Fresh Registration, submitting willingness and exercise choice filling, the schedule of Mop up round of counseling is revised as under :

| 5. | Only fresh registered PCMS incentive category candidates will submit NOC from the competent authority of Punjab Govt. through email (pgadmissionsbfuhs@gmail.com). | 25.03.2022 |
| 6. | The candidates who will apply under Sikh Minority/Christian Minority Quota will report to the respective minority institution (SGRD Institute of Medical Sciences, Amritsar / Christian Minority College, Ludhiana) for verification of minority status. The candidates who have already got verified their minority status, need not to verify again. The candidates who have already registered under Minority Quota during 1 st / 2 nd counseling and did not get verified their minority status, can also verify the same for Mop up round of counseling. | 25.03.2022 |
| 7. | Display of Provisional Merit List of candidates who will submit willingness to participate in Mop up round of online counseling. | 28.03.2022 |
| 8. | Candidates will fill/submit the online choices/ preferences of speciality/college | 29.03.2022 to 01.04.2022 |
| 9. | Processing of seat allotment | Upto 03.04.2022 |
| 10. | Display of provisional allotment / Result | 04.04.2022 |
| 11. | The provisionally selected candidates will pay the balance amount of fee (Six month fee – security deposit) through university payment gateway through university website and will join the respective allotted college | Upto 07.04.2022 |

Conditions/Instructions for Mop up Round

- **The following candidates are eligible for Mop Up round :**
 - The candidates who are registering for the first time.
 - The candidates who have not joined the allotted seat of 2nd Counseling and exit with forfeiture of fee can apply afresh for MopUp Round.
- **The candidates who need not to apply afresh for MopUp Round of counseling**
 - The candidates who are already registered but have not been allotted any seat in Round I and II.
- **The candidates who are not eligible for MopUp Round of counseling**
 - The candidates who are holding/joined the allotted seat of Round I or Round II.

For Mop Up counselling, Fresh registered candidates will have to submit fee of Rs. 5900 (SC Rs. 2950) including GST through University payment. The following is the refundable / adjustable security amount to be deposited at the time of submitting willingness by the applicants through payment gateway through university website alongwith conditions for seats in Govt. as well as Private colleges of State of Punjab :
