

### **Ammendments**

**Consider and Resolved: To recommended to the Faculty of Nursing Sciences for approval regarding Research Center Fee for Guidance of Ph.D (Nursing Sciences) students as under (Pages 92 to 93 of Appendices):**

That the university has fixed Rs.12000/- as HSLIBNET fee against the research facilities to be provided by the respective institution and by the Univerrrsity.TH=his fee will be deposited annually in the research center and it will be started after the registration of student (to be deposited immediately after registration annually, till the submission of the thesis) This fee will be shared by the respective college/research center(it is mandatory that research center should fulfill the eligibility criteria laid down by the University as mentioned in the Ordinances governing Ph.D Program) and by the University in 75:25 ratio(75% for College AND 25% for University).The head of the research center will be responsible to forward the University share of 25%.It is applicable to those students of Ph.D in Nursing Sciences who are yet going to register with the chosen college/research center, as well as will be implemented to all the candidates presently registered at various research center for Ph.D Nursing. Concerned Research Center will issue No Objection Certificate to the Research Scholars who are going to or interested to opt institution as Research Center and help to encourage research and innovation for the betterment of the society.

3.1 The Ordinances relating to Ph.D (Nursing) were approved by **the Board of management in its 32<sup>nd</sup> meeting held on 25.5.2011, vide Para 107.**The ordinance No.3.1 relates to scrutiny of application for Ph.D Nursing, by the Application Screening Committee(ASC).However, the constitution of ASC has not been defined. Hence, the above constitution of ASC needs to be added at the end of Ordinance No. 3.1 relating to Ph.D Nursing.

3.1 Regarding ordinance no. 3.1 of Ph.D Nursing, There seems to be typographical error that line is mission i.e. “ASC will consist of all the faculty members of concerned department along with the supervisor.”

Normally there will be one supervisor for each candidate

5.2 A supervisor will not supervisor the work of more than eighth scholars at a time including Baba Faridkot University of Health Sciences and other university.

5.3 Following shall be criteria for appointment of supervisor co- supervisor.

A) The supervisor shall have Ph.D degree and 10 years teaching experience and research experience after obtaining his/her recognized MS.c(N) degree. He/ She should be scholar at eminence in the field concerned and should have published work.

B) For Co-Supervisor Ph.D degree and 8 year teaching experience and research experience should be after obtaining his/her recognized Msc(N) degree. He/ She should be scholar of eminence in the field concerned and should also have published work.

c) Eligible Post Graduate Medical Teacher having postgraduate qualification with 10 year teaching experience after Post Graduation may be appointed supervisor and co-supervisor.

D) The maximum age of the supervisor will be 67 Years

A co- supervisor may be appointed in special cases such as:

a) If the field the candidate is such that it requires substantial inter- disciplinary input from two or more disciplines.

b) If the candidate is working at a place other than of his supervisor a Co-Supervisor from the place of candidates research work may be appointed provide that he/she should be should be scholar of eminence.

The Supervisor duties of the Co- Supervisor shall be same as that of Supervisor.

A Co-Supervisor will also not supervisor the work of more than five scholars at a time.

**Sub: Regarding the appointment of Regional Co- ordinators for Annual Seminars and approval of Assessment Committee to assess the Six Monthly Progress Reports and Annual Seminar Reports of Ph.D Nursing Candidates.**

**Vide Para no.12 (4) to add Ordinances 6.6 after the Ordinances 6.5 as under:**

“The competent authority of the University shall constitute an Assessment Committee consisting of at least three members having Ph.D qualification, from time to time, who shall consider and assess all the six monthly progress reports and Annual Seminar Reports recommended by RDC. The recommendation of the Assessment Committee Shall be forwarded to the Faculty of Nursing Sciences for consideration and approval.”
