2. **ELIGIBILITY**

- i) The sole manufacturers of Non-digital green based X-ray films or their authorized agents/distributors may quote their rates.

- iii) The firm should have been in existence for at-least three years and it should have annual turnover of at least Rs.50,00,000/- (Rupees fifty lacs only).

3. CRITERIA OF EVALUATION OF PRICE BID

The Price Bids shall be evaluated on the basis of <u>lowest bid criteria</u> without compromising on the quality of material. Rates of all types of taxes as applicable during the contract period should be quoted clearly. No other document / paper shall be attached to the financial bid.

4. **PERIOD OF CONTRACT:**

The Rate Contract will be signed initially for period of one year which can be extended extendable up to another one year subject to satisfactory performance of the firm and timely supply of the material, on the same terms and conditions.

4. **SECURITY DEPOSIT:**
