Sealed quotations are invited for Operation of Canteen at Civil Hospital, Badal, Distt. Sri Muksar Sahib with the following Terms and Conditions and the amount of annual License Fees should be quoted by the bidders.

### **Terms and Conditions:-**

1. Eatable items (list attached) and the rates approved by the competent authority.
2. The contractor cannot make any enhancement in the rates without prior approval of The Registrar, Baba Farid University of Health Sciences, Faridkot.
3. The rate list of all the articles kept for sale shall be displayed in **Bold Manner** near the counter by the licensee at his own cost.
4. The contractor will provide a copy of the GST number certificate alongwith the quotations.
5. The bidder should fulfill all the applicable and mandatory Govt. regulations i.e. Food Safety License Number etc. The copy of the same shall be submitted with the quotation.
6. Prior to issuing the allotment letter, the letter of intent will be issued by the University to fulfill all the conditions i.e. **100%** license fees alongwith 18% GST as applicable in advance and **100%** water charges @ Rs. 750/- p.m. in advance within 15 days and the license fees, water charges and electricity charges will be deposited at the Civil Hospital and all the record of deposition of License Fees, GST, Electricity Charges and Water Charges will be maintained in Civil Hospital.
7. The contractor shall pay the electricity charges on actual consumption basis/ as per meter reading. The record of which will be maintain in the Civil Hospital.
8. The contract period will be **One Year**.
9. Prior to applying for the quotation the contractor and their family members have nothing due towards the University for any type of work. In case of outstanding towards the University the quotation will not be considered and rejected.
10. The contractor shall use raw ration material of good quality, standard make "FSSAI Marked" and of reputed brands.
11. The contractor will have his own crockery, cutlery and cooking utensils. The contractor will have to arrange the LPG fuel at his own cost.
12. The contractor is required to commence the work within 10 days of the issue of allotment letter.
13. The contractor shall employ the adequate number of experienced persons at his own cost. In case of any complaint against any of the employee, the contractor shall immediately replace the particular person.
14. The hygiene and sanitation of the premises shall be the responsibility of the contractor. The University authorities have liberty to carry out any surprise check of the quality of items prepared in the general store at any time.
15. The licensee is not allowed to sublet the Canteen, under any circumstances.
16. On completion/ termination of the contract, it shall be the duty of the contractor to remove all the persons deployed by him and ensure that no person causes disruption/ hindrance/ problem of any nature. At the time of maturity of the contract, the bidder has to obtain NOC from the Civil Hospital, Badal.

**Quotations must be submitted through post/trackable courier. By hand quotations will not be entertained.**





